Nowa. There has been a tremendous amount of undertakings at the Pawnee Nation, with the introduction of new business council members, and with myself transitioning from the Treasurer position to presidency. Remembering my experience as a new council member, I am trying to create a beneficial and relevant orientation for our new council members to get

them acclimated to their tribal administrative/management role as quickly as possible as well as providing a refresher for our experienced business council members. We are finalizing a committees and commissions handbook, which will provide valuable information to those who serve in those positions and assist in providing guidance to key resource or governing documents. This is being done to establish a standard system of operations for committees and commission appointments. The new council members are being provided with tribal governing documents, law and order codes, articles of incorporation, by-laws, etc. so they will be aware of what governs tribal programs, services and tribal entities, such as the Housing Authority, Pawnee Nation College and Tribal Development Corporation. We will have a 2-day orientation training for the Pawnee Business Council and look forward to moving full steam ahead after completion. We have discussed community meetings, re-development of tribal infrastructure, addressing

corrective action plans and most importantly strategic planning. I also would like to stress, the needs, concerns and issues of our tribal members do not go unknown. They may not be resolved as timely as individuals would like them to be; however, we try our best to remedy them in the best way and utilize the resources to the best of our capability, in accordance with the policy, rules and regulations that govern the program. In order to address the needs of our tribal members fully, we will need any and all feedback from you, the tribal member, to participate in the community meetings or other venues or platforms available to make your issues, concerns or recommendations heard. We wish to devise a Strategic Plan that is true to our needs and reflects all the concerns and issues of our Nation. Once this is finalized, we can begin looking for resources to make these priorities and goals a reality. We have historically been stuck in the planning phase but I do not anticipate this as we have very result-oriented and determined

Message from Pawnee Nation Treasurer

Nawa Ahkitadu,

I want to thank all the voters who participated in this year's election, we had a total of 462 voters and it looks like we have some work to do in reaching out to all our constituents/tribal members. During my campaign many folks approached me and brought out issues some of the topics that I heard were: 1. Why should I vote, we do not live in the Pawnee area and therefore we do not receive any services. 2. Travel, where they going and what they bringing back. 3. Accountability throughout the whole Nation including our enterprises. 4. Transparency. In my opinion, everyone should vote, no matter where they reside and even if they do not receive services. Because, it is the ELECTED Pawnee Business Council (PBC) who will make the decisions to serve outside the local and Pawnee area and if you choose not to voice your opinion by casting your votes than this may never happen, you have a choice to vote the best candidate in office who will share in your wishes. 2. It is your sovereign right as a Pawnee, as I stated in my campaign there are a few things that cannot be taken away unless "we allow them to be taken away" our language, our land, our culture and heritage, who our members are and who we vote for as our tribal leaders. The decisions that are made will not only affect you now but your future ancestry for years to come and who knows they may choose to reside in the Pawnee area. Also, we want to build our Nation's economy so that one day

we can be able to provide services to all tribal members no matter where they live.

I feel very confident and excited about our newly elected council we have had 2 regular meetings and 1 Quarterly meeting since inauguration. Although, we are still getting acclimated to our positions, we are also identifying processes and protocols that will maximize our way of doing business. I am still gathering information to be fiscally responsible to you, the people. Once I have all this information I will publish a financial report that shows the current financial status of the Pawnee Nation when I took office. I will provide an update to this report each quarter within the *Chaticks-si-Chaticks* and on the website. Budget call was just issued and we will be conducting budget training June 15-17. The 2016 Comprehensive Budget will be finalized on or before October 1, 2015.

In regard to travel, accountability, and transparency we are reviewing the travel policy, establishing a travel trip report which will identify how the travel/training/conferences will benefit the Pawnee Nation and how it will be implemented. As I and President Nuttle sign checks on a weekly basis we are asking questions and asking for further documentation, if needed. Therefore, I respectfully ask that all employees and tribal members be patient with us and understand that we ask questions not to be directly against you but that we are looking at protecting the assets and resources of the Pawnee Nation, it is not personal. We were elected to and have the responsibility to ensure that we are spending our limited resources in an appropriate manner that limits waste and excess spending. The goal is to ensure that all our funds are expended according to fiscal policies so they do not incur audit findings.

I look forward to serving as your Treasurer for the next four years and working with the entire PBC in establishing our goals and serving the Pawnee people. I hope to see you at Pawnee Homecoming, come by our camp and eat supper with us, we usually serve around 5:30PM, and our camp is the Nuttle Camp located directly behind the East Bleachers!! Tatchikstehu.

Pawnee Nation Chief Judge Dianne Harrold-Barker testifies before the Senate Committee on Indian Affairs

Crime Victims Need Ways To Heal and Recover From Victimization

Chief Judge of the Pawnee Nation District Court, Dianne Harrold-Barker testified June 10, 2015 at the Senate Committee on Indian Affairs Hearing on "Addressing the Need for Victim Services in Indian Country" noting the lack of services for crime victims in Indian Country. Judge Harrold-Barker testified that "Tribes frequently lack any form of victim services infrastructure and where services are available there are still major gaps." She stated that it is important to note that not only do domestic violence and sexual assault victims need services but also that many victims of crimes require services. Such crimes include child abuse, human trafficking, elder physical and financial abuse, homicide and property crimes and many others. Judge Harrold-Barker stated that the victims of these and other crimes are in need of support.

Needed support services described in her testimony include: medical attention and other culturally appropriate services to address physical and non-physical injuries resulting from a crime. Also victim advocates, emergency shelter, crisis intervention services, emergency services and because of the lack of access to transportation, common in tribal communities, emergency shelter and transportation services may be critical. She notes that where a victim lacks transportation, they often cannot seek assistance, go to court, obtain medical care or participate in cultural healing.

Judge Harrold-Barker suggested actions to be taken to address the lack of services for victims of crime include: internal and external collaborations between tribes and service providers including the provision of appropriate services in a holistic approach when victimization occurs in an urban area or

outside Indian Country. She advocated that Tribes also need the resources and support to create criminal codes to ensure that crimes are addressed, including a tribal victim rights code. She also suggested that Tribes create a tribal law that would hold offenders accountable and protect crime victims by making intimidation of crime victims a crime in and of itself. She observed that if Tribes want to opt in to implement the Tribal Law and Order Act, crime victims' services would come at a major cost due to the (TLO) Act's requirements.

PAWNEE NATION POLICE DEPARTMENT

As in years past, the Pawnee Nation Police Department will once again be providing security during this years' 69th Annual Veterans Homecoming Powwow. Officers from the surrounding Tribal Police Department as well as the Pawnee City Police Department and the Pawnee County Sheriff's Department will work together in assuring this years' event will be a safe and enjoyable one. A temporary security station will be located at the football locker room located at the northwest end of the football field for anyone needing information or assistance. In keeping this years' event safe, please remember there will be no illegal drugs, alcohol or fireworks allowed at the Powwow or around the camping areas, this will be strictly enforced. Evening patrols of the campsites will be made during the night of the Powwow.

Pawnee Tribal Members Entitled to Cobell Money

Over 500 Pawnee Tribal members or their heirs may be entitled to almost \$700,000 in unclaimed funds under the *Cobell* settlement. The *Cobell* lawsuit received final approval from the federal courts in November 2012. At that time, the Department of Interior provided to the attorneys for class members, Kilpatrick Townsend & Stockton LLP, and the court approved Claims Administrator, the Garden City Group, the records for approximately 500,000 individuals who may be entitled to payment. However, there was no contact information for about 75% of those people. Often Interior provided a name and a Tribe, nothing more. Therefore, for the past three years, David Smith, an attorney with Kilpatrick Townsend, and Garden City, have been searching for individuals entitled to the money. So far, over 90% of the funds have been disbursed, including over \$4 million to more than 1500 Pawnee Tribal members. However, with the help of the Tribe we want to locate and get the money to those who have not yet received it.

Those entitled to participate in the settlement are tribal members who were living on September 30, 2009, or who had passed away and their estates were in probate on that date and who had an interest in trust or restricted land on September 30, 2009, or had an Individual Indian Money ("IIM") account with at least one transaction in it at any time between approximately 1985 and September 30, 2009.

Below is a list of individuals identified by the Department of Interior as living or deceased members of the Pawnee Tribe who *may* be entitled to a payment. This year marks the 69th Renewal of the Pawnee Indian Veterans Homecoming

The 69th renewal of the Pawnee Indian Veterans Homecoming and Powwow begins on Thursday, July 2, and continues through Sunday, July 5, 2015, at Pawnee's Memorial Field.

Once billed as the "Largest FREE Indian Powwow in the World," the first Homecoming was held in 1946 at the Dollie Moore campgrounds to welcome home the men and women from the great war. The first Homecoming was several years in planning by World War I veterans, various tribal service organizations and tribal members.

At the conclusion of that first Homecoming, the returning combat veterans formed the Pawnee Indian Veterans Organization and they decided to continue the Homecoming as an annual event, to be held the first weekend in July. That tradition continues.

Since that time, tribal members and Pawnee community members who live across the country plan their annual pilgrimage to Pawnee for the Homecoming and related 4th of July festivities, along with many other visitors who come to town.

The current Veterans Organization, in conjunction with several programs within the Pawnee Nation, have put together a long list of activities for veterans, visitors, tribal and community members, for this big holiday celebration and its all FREE . . . free parking, free admission, free camping, free

rations to all campers.

This year's Homecoming is dedicated to the memory of Chester LeadingFox, a tribal member who served in the military for over 22 years and in three wars. He will be recognized on the 4th of July.

Probably, one of the most important activities is the raising of the Veterans burial flag each morning in honor and memory of deceased tribal veterans. Each year, the Veterans select four tribal veterans to be honored on each of the four days of the Homecoming. The flag is raised each morning at 7:00 a.m., at the southeast endzone of Pawnee High School's Memorial Field and flies throughout that day's activities.

This year, on Thursday, July 2, 2015, the flag of Elinor "Sarge" Fields, a WWII veteran will be raised and signals the start of the 69th annual Homecoming. The flag of Roberta Gardipe will be raised on Friday, July 3. Besides her service, Roberta served many offices in the Veterans organization, including President. She was also the first woman Keeper of the Drum for the Veterans organization.

On Saturday, July 4, the flag of Chester LeadingFox will be raised. He had a brief enlistment in the 45th Infantry Division before WWII, then joined the Navy during WWII, then transferred to the Air Force immediately following WWII and served during the Korean War and the Vietnam War, retiring after serving over 22 years.

St. Elmo Wilde's flag will be flown on the final day of the Homecoming. The Saint served in the Army National Guard. He was an active member of the Pawnee Indian Veterans Organization, serving as the President. He was also a noted Arena Director in Pawnee and at other Indian celebrations across the country.

Each evening's activities begin at 7:30 p.m. On Thursday, usually termed Indian Night, the activities are light, giving everyone a chance to meet and greet old and new friends. The Tiny Tots contests for boys and girls highlight the evening's activities. Prizes are donated by the Pawnee Nation's Diabetes Program. Inter-tribal and other dances will also be held.

Friday, July 3 is a big night and the activities begin with the Invocation, followed by the Parade-In. The selection of the 2015-16 Veterans Homecoming Princess will be made. The 2014-15 Veterans Homecoming Princess Dalecia Satepauhoodle, will assist in the coronation ceremony.

Herb Adson sponsors a special Men's Straight Dance Contest; followed by another special to recognize first time dancers. The Junior Girls Contests, Cloth, Buckskin, Fancy Shawl/Jingle will be held followed by the Junior Men's Contests, Grass/Traditional, Fancy, and Straight.

Following the flag raising on Saturday, July 4, free rations will be handed out to all campers, beginning at 8:00 a.m. The Mose YellowHorse Coed Softball Tournament,

coordinated by the Travelers Club begins at 8:00 a.m. At noon, the Mile-Long Homecoming Parade will be held in downtown Pawnee. The evening's activities begin at 7:30 p.m., with the Invocation, followed by the Parade-In. A Special Straight Dance Contest will be held for youngsters, 7-12 years of age., followed by the Senior Women's Contests.

On Sunday, July 5, the 34th annual Hawk Chief 5K Run will be held at 8:00 a.m., starting and finishing at the Memorial Field track. Church Services at 10:00 a.m., at the church of your choice.

Invocation at 7:30 p.m., followed by the Parade-In. The Golden Age contests, men and women, ages, 61 and over, will be held. The Senior Men's contests will also be held.

Drum Keeper is Lance LeadingFox. Head Singer for the Homecoming is Pat LeadingFox. MC is Warren "Junior" Pratt, Jr. Arena Director is Grant Hawkins. Homecoming Chiefs are: Richard Tilden, Skidi; Tim Jim, Pitahawirata; Joe Hawkins, Jr., Kitkehahki; and Matt Reed, Chaui.
