



## MESSAGE FROM THE PRESIDENT

Nawa Akitâru, and greetings tribal members. This is my first report on the State of our Nation. I assumed office on July 6, 2020, along with newly elected Treasurer Carol (Chapman) Young and Councilwoman Cynthia Butler. The new Business Council will be complete upon the election of a Vice-President on August 22, 2020.

The first half of this year began with internal political turmoil and the onset of the COVID-19 pandemic. As the infection spread, PBC leaders were engulfed by divisive recall, replacement, and run-off elections; and by several lawsuits that brought internal political disputes into the Tribal court system. In the recall and replacement elections, Pawnees voted to stabilize the government and restore unity in our leadership. We owe them a great debt of gratitude for coming to the aid of their Nation in a time of need. And we are thankful for our hard-working, dedicated Tribal employees who carried on the government operations and addressed the public health emergency. On August 6, 2020, the Pawnee Nation Supreme Court upheld the last recall election. The decision closed the chapter on political upheaval. It is now time to come together in good will and move forward as one united people.



Since I came to office, the uppermost concern of the Tribal government is to safely navigate the Coronavirus Pandemic. Not a week goes by without someone we know having a brush with infection; and the spread of infection in the State of Oklahoma continues to grow.

While the Tribal Emergency Response

Committee (TERC) continues its work to strengthen and monitor public health measures for the Pawnee Reservation, I formed a supplemental School Reopening Task Force composed of Pawnee educators and public health leaders to assess the public health measures of the Pawnee Nation Learning Center, Pawnee Nation College, and all public schools within tribal jurisdiction. We found that Tribal measures for the Pawnee education institutions comport with federal public health guidelines. The Task Force worked with the Pawnee Public School Superintendent and School Board officials to strengthen measures for a safer education this year; as a result, masks are required for all grades preK-12; and the online option has been extended to all grades as well. To bolster these measures the Business Council provided Covid-19 Relief Fund money to the Pawnee Public Schools for school supplies needed by more than 200 Native American students; and more relief is on the way for PPE for all public schools in our jurisdiction to strengthen public health protections that will inure to the benefit of nearly 500 Native American students. We also plan to beef-up our capability to provide on-line education opportunities at Tribal facilities throughout the complex for those students who choose the safer on-line option offered by the Pawnee Public Schools. In a similar vein, I am initiating exploratory meetings with the City of Pawnee and Pawnee County on an intergovernmental basis to explore ways to better protect the local community from the spread of infection. My hope is that the City and County will align their public health measures with those of the Pawnee Nation, IHS, and the Pawnee Public Schools--so everyone in our community can enjoy uniform protection against the spread of infection.

On August 8, 2020, the Pawnee Business Council hosted a Virtual Covid-19 Forum to brief Tribal members about the Pawnee Nation's CARES Act Covid-19 Relief funds and the legal guidelines for spending those funds. In the morning session, presenters discussed a wide range of needs

and proposals for addressing the Pandemic; and a Listening Session was convened in the afternoon for tribal members to express their needs, concerns, and suggestions for spending the CARES Act relief funds. Tribal members gave presentations and were afforded the opportunity to submit written statements as well. The Forum video is posted so all Tribal members can access that information. Input received from the Forum will assist the new Business Council in deciding how to spend the remaining CARES Act Relief funds to address the Pandemic in the best way possible. I thank the Business Council members for hosting this Forum and their participation in it, as well as Tribal staff for putting this virtual event together, and especially each presenter for providing constructive suggestions. With Atius' help, together we will address this Pandemic, and persevere.

The Pawnee Nation economy has been hit hard by the Pandemic. To its credit, the Pawnee Tribal Development Corporation (PTDC) has partially reopened its businesses, but revenue is down as it continues to cope with difficult financial times imposed by the Pandemic. The Stonewolf restaurant was closed this summer and lay-offs were made to keep PTDC businesses afloat. As PTDC tightens its belt, the Business Council is keeping a close eye on those developments and is looking for ways to assist the business arm of our government in navigating the Pandemic.

During this period, work was done to strengthen the Tribal government's infrastructure. Business Council members are examining our committees, commissions, and boards to see what appointments should be made, how to consolidate overlapping work, and what new committees need to be established. In addition, the Pawnee Nation Handbook for Committees, Commissions, and Boards is being upgraded. We are creating a Human Resource Bank composed of talented Pawnee professionals that can be called upon as volunteers to lend their expertise to our committees, commissions and boards, as well as to assist special projects initiated by the tribal government. These efforts to

strengthen our governance are on-going.

The Pawnee Business Council is in a strategic planning mode. With input from Tribal employees and members, we want to define what the “promised land” will look like for the Pawnee Nation down the road, then figure out how to get there by action items to be taken over the short, mid-term, and long-term periods. We want to get everyone on the same page, rowing in the same direction to take our Nation to the next level through strategic planning. This effort will be led by the Planning Division with proactive participation by the Business Council. At the same time, we are encouraging the Pawnee Tribal Development Corporation to engage in strategic planning as the economic development arm of the Business Council; and I understand that the Pawnee Nation College is also engaged in strategic planning for the college. Visionaries we must be to reach our aspirations as one people—so our people can live in a Pawnee world of our own making. That is the essence of self-determination. Let us go on this planning journey together over the next couple months, so our Nation will endure.

In this complex world, every successful modern-day Native Nation in the top-tier that has reached its “promised land” has had an outstanding legal team at its side every step of the way. The Pawnee Nation has strengthened its legal team with the addition of Attorney General Chad Smith. He works with other attorneys to address the legal affairs of the Pawnee Nation, such as Earth Justice. The legal front has been active since I came to office due to activity in several pending lawsuits involving the Pawnee Nation. As mentioned earlier, in *Whiteshirt v. Election Commission*, the Pawnee Nation Supreme Court upheld the last recall election in a decision handed down on August 6. A decision by the Supreme Court is also expected anytime in *Whiteshirt v. Mason*, which involves a claim for attorney fees. Settlement discussions are underway in the Pawnee Nation’s earthquake damages case entitled *Pawnee Nation v. Eagle Road*, et. al; and successful settlements with some of the smaller defendant oil and gas

companies have already been achieved. The federal court lawsuit entitled *Pawnee Nation v. David Bernhardt*, Secretary of the Interior, involves a legal challenge to several flawed BIA and BLM oil & gas approvals on Pawnee allotments. This case has been briefed and argued; and we expect a ruling by the federal court anytime. The same is true for related administrative appeals on submission before the Interior Board of Indian Appeals (IBIA). These oil and gas legal matters, which are designed to force BIA & BLM compliance with Federal and Tribal law, are being handled by EarthJustice, and our Attorney General entered his appearance as local counsel in the *Bernhardt* case. Finally, all tribes are examining the impact of the U.S. Supreme Court decision in *McGirt v. Oklahoma* which ruled that the original boundaries of the MCN still exist and the state has no jurisdiction to prosecute crimes committed by Indians within those boundaries. To keep abreast of that legal development, I hope to examine the impact of that decision on Pawnee Nation’s original reservation boundaries in the coming weeks.

I want to congratulate our new Pawnee Nation Princess, Haley (Teter) Johnson. Her Pawnee name is Tutawi’u (Full of Life). She will do great, for she comes from a long line of Pawnee Princesses; and I wish her the best in representing our great Pawnee Nation. I am proud of our young people who are reaching for the stars. We are inspired by our professional Pawnee boxer, Mr. Dennis Knifechief. This proud and prayerful man is a role model, because he exhibits the courage, endurance, and strong mental attitude it takes to “put it all on the line” in the ring. This kind of determination is the mark of a Pawnee warrior. Pawnee filmmaker Maggie (Rice) Cunningham is another inspirational role model in the arts. She received a 2020 Emmy Award Nomination for her splendid work in “A Powwow Education.” It is fitting that we honor and thank these role models, because they inspire everyone--and make our Nation proud.

Finally, I want to thank the dedicated staff and employees of the Pawnee Nation. In

my short time in office, I cannot state how impressed I am by your skills, devotion, team spirit, competence, and hard work during these troubled and uncertain times. You too are role models in my eyes; and I thank you for your service to the Pawnee People. I continue to be impressed by the wide range of complex government activity that takes place at the Pawnee Nation every day. There are many moving parts to this government that keep our Nation moving forward. I look forward to working with each of you as we stride toward a better day.

### **PRESS RELEASE**

The Division of Planning & Tribal Development is excited to announce the Pawnee Nation of Oklahoma has received funding thru the Department of Housing and Urban Development (HUD) for the FY-2019/2020 Indian Community Development Block Grant (ICDBG) and the Indian Community Development Block Grant Coronavirus Aid, Relief and Economic Security Act (CARES) (Public Law 116-136); totaling \$1.8 million dollars.

- June 4, 2020, HUD announced nearly \$120 million in FY-19/20 ICDBG awards, this funding will be used to support 107 projects on tribal land across the United States. The ICDBG program provides funding to use in the development of American Indian/Alaska Native communities which includes:
  - Housing-housing rehab, land acquisition to support new housing construction and new housing.
  - Economic Development-various commercial, industrial, agricultural projects.
  - Community Facilities-infrastructure construction and single/multipurpose community buildings.

The Pawnee Nation of Oklahoma received \$900,000.00 to expand and construct on the current Division of Natural Resources and Safety building to be renamed the Pawnee Nation Public Safety Center. The facility current houses the Department of Environmental Conservation and Safety, Department of Fire & Rescue, PN Department of Transportation and Department of Emergency Management. Expansion/construction will consist of enlarging office space, additional covered equipment bays, more parking area and an addition of a training and fitness area. This project was approved by the Pawnee Business Council on February 1, 2020 by resolution.

- July 22, 2020, HUD awarded over \$20 million in funding for ICDBG Imminent Threat program under ICDBG CARES, to help Tribes prevent, prepare for, and respond to COVID-19. This is the 4<sup>th</sup> round of funding of \$100 million that will be going to Tribal Nations. As of today, HUD has awarded a total of just over \$71 million dollars under this program.

The Pawnee Nation of Oklahoma received \$900,000.00 to provide rehabilitation of housing ventilation systems to homes that need install, repair, replace of heat/air units (within jurisdiction), provide food packs/boxes to families (within jurisdiction), and an upgraded fire truck with hazardous material capabilities to expand medical and other emergencies services. This project was approved by the Pawnee Business Council on May 20, 2020 by resolution, AMENDED on June 26, 2020.

# Native Connections

The Pawnee Nation is pleased to announce that we have been awarded a 5-year grant from the Substance Abuse and Mental Health Services Administration (SAMSHA) titled Native Connections. This will be housed under the Health & Prevention Department of the Division of Health and Community Services. The purpose of this grant is to prevent suicide and substance misuse, reduce the impact of trauma, and to promote positive mental health for youth and young adults in the Pawnee area. In the early stages of the Native Connections grant, we will be collecting data from focus groups, community meetings, and surveys. By obtaining this pertinent information, it will help us determine what activities and education materials will be most helpful to the youth and

young adults. Native Connections will help the Substance Abuse Program, Methamphetamine & Suicide Prevention Initiative, and Tribal Opioid Response continue to provide educational and substance-free activities for the youth in the Pawnee area. Some of the prevention activities that will be provided include spring break and summer camps, procuring motivational speakers who will speak on suicide and substance abuse, holding “Talk Saves Lives” trainings, and several events promoting Pawnee Nation’s culture and traditions. Our main goal with the Native Connections grant is to increase the capacity within the tribe and community to reduce the high-risk behaviors that lead to suicide and substance abuse among our youth population.

# Division of Health & Community Services News

The Pawnee Nation is pleased to announce that we have been awarded a 4-month COVID-19 Telehealth Mini-grant through the National Indian Health Board (NIHB) with funds from the John Hopkins University Center for American Indian Health, as part of the national Nick Kristof’s C-19 Impact Initiative. This will be housed under the Division of Health and Community Services (DHCS). This project is aimed to strengthen DHCS’s

local COVID-19 response by building capacity and responding to telehealth services and needs. Areas to improve include Materials & Equipment Acquisition, Facilities & Infrastructure, Outreach and Education, Training and Technical Assistance, and Evaluation & Assessment. This project will not only provide benefits on an individual level; it will enhance the tribe’s ability to provide services remotely (if needed).



# Food Distribution Program News

The Food Distribution Program is excited to inform our participants that the program will participate in a distribution pilot for shelled eggs, which will begin in October 2020.

The program has been waiting many years for the shelled eggs to be available to the program. One dozen shelled eggs (individual dozen cartons) will replace two units of dried egg mix that participants receive each month. During the pilot, the dried egg

mix will not be available. The shelled eggs will be delivered weekly, along with our produce orders.

We want to remind tribal and community members to continue practicing heat safety, drink plenty of water, and move your bodies! We encourage you to protect yourself the best you can by taking necessary precautions against COVID-19.



# Pawnee Nation Substance

**Abuse/MSPI/TOR** programs have needed to make adaptations during this stretch of the Covid-19 pandemic. With the reduced outside community group activities with MSPI and TOR programs, as well as limited face to face contact with individual clients and support group meetings with the Substance Abuse Program being cancelled or revised, our programs still need to serve our people as best we can under the circumstances.

The MSPI and TOR programs have spent time working on extensions due to the Covid-19 incidents to continue to serve the community as the ability to function in a manner that will provide the most benefit is determined. These programs will again begin working with the school system as well as other community programs to identify areas of concern and provide best practice and evidence-based approaches to the at-risk areas of concern.

The Substance Abuse Program is seeing individuals by appointment only. A person seeking assistance needs to call **918-762-2143** to schedule a time for an appointment or to get assistance from the program to get into inpatient treatment. The Substance Abuse Program has added an additional evening Support Group. It now has **Monday** and **Wednesday** evenings at **7:00 PM** as the scheduled times. Due to social distancing requirements, we have needed to limit the attendance to each of the meetings. This again will require a reservation to be made before the day of desired attendance by calling **918-762-2143** and speaking with Barbara Attocknie or Mike Ortiz to ensure a place is available.

There are many other concerns associated with the Covid-19 pandemic for our community. We will list some of the Hotline and Helpline numbers that may be of help to someone in need during this time frame.

Another area of concern contends with rape, abuse, and incest during this time frame. The **RAINN** (Rape, Abuse & Incest National Network) also provides assistance at **1-800-656-4673**.

The **LGBTQIA** group also provides resources through the Trevor Project at **1-866-488-7386** or text **START** to **678678**. There is also the **Trans Lifeline** at **1-877-565-8860**.

The above-presented numbers have been provided because they often time tie in with substance misuse/abuse. This number is provided as the SAMHSA National Helpline at 1-800-662-4357.

We will continue to provide all the help we can for our community needs in the office. However, these resources can be very helpful during a specific time when someone cannot be reached in person. The people that answer these numbers are all well trained to help assist someone in any way they can and should be used when a time of crisis appears. Let's all continue to use safe practices such as wearing a mask, social distancing, and constant washing of hands to reduce the spread and provide our community with the opportunity of a bright future.



The impact of the COVID-19 pandemic has largely overwhelmed many of our tribal communities and operations. In an effort to help alleviate the undue burdens and work through the many challenges, Tribal members must be counted in the 2020 Census before the September 30 deadline. An accurate and complete count is critical to Tribal members who live within and outside the Pawnee Nation jurisdiction.

**The 2020 Census is a way to get back what you put in.** Every 10 years, the U.S. Census Bureau counts every person, including babies born by April 1, living in the United States. This confidential Census count determines where the more than \$1.5 trillion in federal funding goes to support important community needs, like schools, health care, food assistance (SNAP), treatment for clean drinking water, and housing that benefit everybody. Unfortunately, our tribal community like many others, were not completely counted in previous Census efforts.

**The Census data has also been an important factor in COVID-19 aid.** A complete count helps public health officials and tribal leaders direct funding to better protect our communities and weather this pandemic. Population data taken through the [Census count helps communities plan funding for hospital clinics and emergency services](#) across the country. Census data ensures thoughtful emergency planning, allocation of resources, deployment of front-line responders, and determination of the amount of future vaccines. Previous Census data has also been used to determine the amount of CARES Act funding which was not a 100% count. It is without question that aid to communities is impacted by Census participation.

**The 2020 Census is available to be completed with safety in mind.** Everyone can respond to the Census online, by phone, or by paper form which comes pre-stamped, but for those households who haven't responded, Census takers are going door-to-door to collect responses.

Everyone must play a part to make sure our community stays safe and gets the funding for necessary vital resources. We must count all Tribal members to secure the funding we deserve and to build a stronger future together.

Stand up and be counted.

As a team we have quickly moved forward in an environment of good will, cooperation, and peace to serve the needs of the Pawnee people during this dangerous pandemic.

It is with thankfulness to our creator that I report a positive financial status to the Pawnee people. The financial state of the Tribe is in a good place thanks to the oversight of the four council members who remained in office as our people prepared to vote in new leadership. I applaud the four council members for holding the government intact, taking care of the finances, and insuring the continuation of services to Tribal members.

As I assume my duties and learn I am witnessing the work of our previous Treasurer Angela Thompson who held the office for numerous years. I would like to acknowledge and thank this highly, talented, knowledgeable, committed young Tribal leader whose fiscal knowledge and skills are reflected in the good state our Tribal finances. This young Pawnee woman is responsible for our Tribe having a clean audit. She operated on a vision, a plan, and leadership which has left the Tribe with the ability to go forward with a clean record to pursue grants and business ventures. This will allow the council to pursue grants and other endeavors to increase growth and services for the benefit of our Tribe.

Currently, the Pandemic funds have been the intense focus and task for spending under the stewardship of the council. President Echo-hawk's leadership provided an open forum for all Pawnee people to share their voice on the COVID-19 Pandemic funds. The council has been working extremely hard at completing due diligence as stewards of this important task investing much time and dedication. Exemplary employees have assisted to complete this task to be completed by the end of December. This must all be completed in a

very short amount of time.

With good staff, team spirit, and united leadership in place we now go forward with the most important task of the moment. Pawnee Nation has been awarded

1. CARES Act funding (Pawnee CARES – Corona Virus Relief fund): for \$10,130,455; and
2. CARES Act funding (Pawnee Nation – Aid to Tribal Government): \$1,250,319.

Prioritizing and allocating these funds remains a work in progress and will be reported to the Pawnee people on the Pawnee Nation website to keep membership informed. The council has difficult decisions to make and is working hard to identify needs well, wisely weigh what must be done to protect our people and make the best decisions possible. My time in office has been short and I have shared what is available to date. I will continue to provide updates and reports to our people.

## PAWNEE TRIBAL DEVELOPMENT CORPORATION (PTDC)

The health and safety of our employees and customers are of utmost importance to our Board of Directors and leadership.



Masks are required to enter all our facilities-retail and gaming. Additional precautions include temperature screenings upon entry into gaming areas, personal protection panels installed at every machine at the Tee Pee Casino, Trading Post Casino, and the

Travel Plaza gaming area. New hours at StoneWolf allow staff to do deep cleaning and sanitizing daily.

All three Pawnee Nation Casinos were closed on March 18th, 2020, because of health and safety concerns due to the COVID-19 Pandemic. With new health and safety precautions in place, StoneWolf Casino opened on May 15th, 2020, Tee Pee Casino opened on June 4th, 2020. The extended gaming floor in the Travel Plaza opened on July 24th, 2020. After the remodel was complete, the Trading Post Casino opened on August 3rd, 2020. As we welcomed both employees and guests back to our casinos, company-wide COVID testing was required for all employees.

The remodel creates a much needed, much more inviting atmosphere with a new HVAC system, new smoke filters, and a raised gaming floor. The renovation introduces a new Mazzio's Go that utilizes the deli area. The new Mazzio's Go offers all of the same products offered by our Mazzio's Go at the Travel Plaza, including sandwiches, salads, wings, and pizza.

Due to the financial ramifications of the Pandemic, Howler's Restaurant at StoneWolf Casino is closed indefinitely. New restaurant options are being considered for replacement. The StoneWolf bar is still opened.



## MESSAGE FROM PAWNEE NATION EXECUTIVE DIRECTOR



The Pawnee Nation has completed 5 months of being under an Emergency Declaration due to the COVID-19 Pandemic. Our Elders here in Pawnee are still receiving their noon meals at home and some have elected to come to the Elder's Facility to pick up their meals from the Title VI staff who have set up a temporary drive through for these individuals. Tribal workers are required to have their temperature taken as they report to their respective offices or as they go from one building to another. There have been instances where an office or a building has been closed due to either an employee testing positive for COVID-19 or being exposed to COVID-19 and these instances have been dealt with the affected office area being sanitized before worker can return to the office.

As you probably know, the Pawnee Nation issued COVID-19 Relief Checks to the adult Tribal members who submitted a completed application that stated that they

and/or their families have been directly affected by the COVID-19 Pandemic. If you have not submitted your application for this relief fund, then please get those in as soon as possible.

The Relief Checks for the children that are under the age of 18 have started to receive their assistance checks, so that their parents may be financially able to purchase electronic equipment for the children so that will be able to do their school assignments at home.

The Pawnee Nation is developing a safe space for our children to do their homework at and also have internet access to the classes that the Pawnee Public Schools will be doing online. An ad hoc committee has been working with the Pawnee Schools on this project. The "Study Hall" is projected to open on September 01, 2020. The proposed plan is for those Pawnee students who have already made a decision to not attend classes in person at the Pawnee Public School but to attend online have the option to utilize this program that we have set up at the Pawnee Nation. The proposed site for those students who do not have internet access will be to go to the Multi-Purpose Center located on Morris Road. Desks areas will be set up as to comply with social distancing while they are participating in the Tribal study hall program. All students

will have access to any protective supplies that the students need such as masks or hand sanitizers. This site will also be available to our college students that need internet access for their classes.

Due to the recall elections that were held earlier this year, some of the positions needed to be filled in an election that was held in June. The results of this election resulted in three out of four of the open seats were filled and one seat will be filled in a run-off election because none of the candidates received 51% of the total votes cast. The following positions were filled; Walter Echo-Hawk became the new President of the Pawnee Business Council, Carol Chapman Young won the Treasurer Seat and Cynthia Butler claimed one of the non-officer seats on the Council. The Vice-President position will be decided on August 22, 2020 in a run-off election.




