Bernie Sanders, the democratic candidate for the Presidency, is looking to visit tribes and visit the Pawnee Nation. On January 12th attended the PNRC pre-bid meeting, 21st Health Board meeting at IHS, the Ponca tribe was a few weeks away from doing a dialysis center, the Osage gave a report on using AmeriCorp grants and what they provide. Mr. Pratt Attended the conference call for budget call for IHS, conference call for national institution of health. Today Congressman Lucas' staff visited and there was discussion on the funds the Pawnee Nation are seeking with them on the after school program.
