4. Presentation and Discussion by Scott Poynter, Earthquake Litigation

Mr. Scott Pointer presented to the Council on the earthquake damage to homes and the Nation. Mr. Pointer is asking the Nation to allow him to take the lawsuit into Tribal Court to hold people accountable. This is a long term solution and it has to do with the oil and gas industry. The contract has been presented and they will front the cost if the Nation decides to approve the MOU.

The Council will meet on February 2<sup>nd</sup> to talk about the MOU and make a decision at the February 4<sup>th</sup> Pawnee Business Council meeting.

5. Approval of Request from Skidi Leading Fox, Princess for the Greater Indian Arts Festival

Motion made by Phammie Littlesun to refer this request to the Budget Committee, seconded by Sammye Adson.

Mr. Spottedhorsechief would like the Nation to send a letter to President Trump to voice the displeasure of the Nation. An AP release that we do not agree with his decision of allowing work to continue. Requesting to draft a letter directly to President Trump. Suggestion is to include the legislature.

Ms. Adson would like to watch and see what is next to come before sending a letter.

President Pratt gave his opinion on sending a letter and asked the Council to be careful with what is written because the PBC represents the Nation. Does not want any bad light on the Nation.

Mrs. Hare suggested in taking a diplomatic approach and express in the letter the concerns of the Nation. She would also like to see in the letter the history of the Pawnee never waging war and include our Pawnee Scouts.

Motion made by Dawna Hare to approve a letter to send to the President, Congress and the Senate to voice the concerns of the Nation, seconded by Adrian Spottedhorsechief.

<u>Vote:</u> All in favor, none against, none abstaining and one not voting. Motion carries.

Sammye Adson: concerns on late construction at the Travel Plaza; break camp at Standing Rock and she would like to see those who went up there to be reimbursed expenses; when a body is in state, the lack of respect to the family in mourning.
