Call to Order & Invocation I.

Secretary Phammie Littlesun called the meeting to order at 9:16 A.M. Adrian Spottedhorsechief gave the invocation.

Approval of Agenda III.

IV. **Committee Reports**

Council members provide reports of their committees and meetings since the last PBC meeting.

Tribal Development Corporation Report V.

Mr. Roger Smith, TDC CEO was present and reported on the close of the purchase of the building. The loan is being approved to purchase snack n pack and another building, purchasing those businesses, the loan is

pending the appraisals. The auditors we here last week to do 2014 audit, Mr. Smith reported they had a clean audit and also mentioned they are working on the master plan for the expansion at StoneWolf.

VI. Executive Director Report

Executive Director, Lisa Gover was present and reported on the activities of the Executive Office. She reported on the activities that the programs are working on. Ms. Gover also gave a brief report on her NCAI Winter Session Conference trip to Washington DC.

1. Update on Water Issues

The Business Council talked with Mr. David Gover, attorney working the water negotiations for the water issues with the City of Pawnee.

Mr. Gover reported on the purchase contract with the Nation and the City of Pawnee. There is a question on whether the Tribe will be able to sell water to the City. This will have to have Federal approval. Working to schedule meetings with the BIA and field solicitors, and meeting with the solicitor's leadership in Washington. The other issue is that the City is in current elections and the current Major has an opponent and it may be a close election. After the election then they can focus on the agreements to be finalized after that.

Jimmy Jestes mentioned that the City is waiting until after the elections to make sure that the agreement is going to be finalized and signed.

Mr. Gover mentioned that they have put the applications in to the BIA and that is pending and they will be reviewing to make any decision. He is just waiting on the work for that program.

2. Update on PNE Wind Lease

Phammie Littlesun requested this to put on the agenda and mentioned that the Business Council decided to decline the lease. Ms. Littlesun had hoped to talk to the attorney, Gwenellan Janov for an update but Ms. Janov is unavailable but did send a written update.
