#### I. Call to Order & Invocation

<u>President Marshall R. Gover</u> called the meeting to order at 9:25 A.M. Adrian Spottedhorsechief gave the invocation.

#### IX. Open Forum

Ms. Yvonne Fletcher said that on March 20<sup>th</sup> she was waiting for someone to pick her up for breakfast over at Title VI. She called and called and no one answered the phone. She walked to the bottom of the hill and waited and no one offered to pick her up. She then saw Richard Robedeaux was driving the red van, she found out that Georgene Williams was told not to come in that day and she was needed. Ms. Fletcher had some concerns, along with other elders about the food, Deb Echo Hawk and other issues about the programs property.

There was discussion on some of the issues, President Gover asked Ms. Frietze to take care of some of the issues at the Title VI.

Ellen Whiteshirt had some concerns about the Maintenance department and the authorization and use of the Tribal vehicle.

Monie Horsechief mentioned to the Council that she taught a class for the Office of Violence Against Women program and signed a contract and submitted her invoice. She has not received any payment from the program since from February. She just needs clarification on why she is not being paid.

President Gover mentioned that he will find out what the holdup is and report back to her.

Tiffany Frietze apologized to Mrs. Horsechief about the delay and did let her know that the check is in finance and it is waiting on signatures.

Walter Lorentz addressed the Council about his sister passing away this morning. He is asking the Council for funds or any help that he can to get down there to his sister. He also asked about the burial fees for the funeral home as well.

Mr. Gover offered his condolences to Mr. Lorentz and let him know about the burial policy.

Mr. Lorentz asked what the tribe is expected to do.

President Gover told him to get a hold of the Executive Office and they will help with anything that needs to be done.

Ellis Horsechief thanked the Council and the people for their generosity towards Mr. Lorentz.

John Only A Chief thanked the Council for postponing the appointments to TDC and wanting to do the interviews. He urged the Council to attend a meeting over there and see for them what goes on there. Mr. Only A Chief had some other concerns about the TDC Board and Corporation.

### More Discussion on TDC and concerns going on over at TDC.

Mr. Tilden said that when he was young he would always stop and pick someone up when they were walking along the road. He wanted to encourage everyone to pick people up if they are walking, especially our elders.

President Gover asked Mr. Pratt say a prayer to close out the meeting.
