Jimmy Whiteshirt addressed the Business Council for a request for a Resolution to conduct a forensic audit on the Pawnee Nation gaming revenue. Mr. Whiteshirt will be back in thirty days to find out the decision of the Council.

Mr. Whiteshirt questioned the PBC if there is anything amiss with TDC right now that the Pawnee People need to be concerned about.

M. Angela Thompson answered with action that was made by the TDC Board in an Emergency Meeting held yesterday evening. The decisions were made based on the report of an active Pawnee Nation Gaming Commission investigation going on and she stated she cannot give details on. The Tribal Development Board took action on the following: (1) Suspended current CEO until further notice, (2) Authorize acting Chairman, Jeff Goodfox to activate a plan to identify acting CEO, (3) changing of signature cards for signature authority, and (4) to engage the TDC attorney to look at two contracts with Tepee Casino and CEO.

The TDC Board will meet on Tuesday Evening to make further decisions on the issues.

10. Presentation from Jasha Echo-Hawk for Political Support (15 min)

Jasha Echo-Hawk addressed the Business Council to ask for support in her political campaign for State House Representative, District 35.
