They want to have a fundraiser and ask the Pawnee Nation to go up there and put on a dance. On September 30 they will have a meal and dance at the school building in Kansas. The family is looking to donate the land back and buffalo to the Pawnee Nation after the lodge is built.

The Land Management Committee will look into getting in contact with the family on the land acquisition. August 31 at 2 pm, Land Management Meeting to have discussion.

Charles Knife Chief: Asked Sammye Adson some question about information being given to Council; asked for feedback from Council on per capita and how it will affect services during the budget cuts; talked about water bottling;

Sammye Adson: mentioned that her mother received an offensive letter and she did not appreciate it
