Yvonne Fletcher: let the Council know that she got her grass mowed; attended the TDC Board meeting:

Jamie Nelson: addressed the Council on the incident with the Nordwalls; asked the President to clarify the actions;

Sammye Kemble: gave her opinion on what happened;

More discussion on the incidents happening around the Nation

Ann Collins: made 12.00 on her cookies; selling bids on a shawl;

Sammye Kemble: Pawnee Language class is starting up and grateful to have that come back

Keller Roaming Warrior: addressed the people and told everyone he loves all his Pawnee People; don't be mad at that boy, he was angry, be mad at what he did;

Carol Nuttle: Spoke of looking at the bigger picture and how it affects everyone. Has questions for President Whiteshirt. Asked about his statement in Chaticks si Chaticks about millions of dollars that was lost, where did the money come from?

President Whiteshirt: responded that the money was gaming money

Ms. Nuttle: asked who is doing the investigation?

President Whiteshirt: at first it was the IRS, they determined that it was not a civil action but criminal and it was turned over to the FBI for further investigation.

Ms. Nuttle: did you ask the IRS to come in and ask to investigate?

President Whiteshirt: all of this was initiated before I was elected.

Ms. Nuttle: Since you were on the PBC, have you told this Council and met with the Council to discuss the IRS and FBI investigation?

President Whiteshirt: nowhere does it say in the Constitution, or in the policies, that he has to inform the Council. But if someone can find that, he would like to see it.

More discussion on the President's actions concerning the IRS and FBI investigation

Linda Jestes: requested a meeting with the BIA on Trust Property; has had questions on probate and property, would like to request permission to hold a class to help the people with their questions; asked about cleanup of the kitchens and cooking equipment;

M. Angela Thompson: will have to look at the budget to see if there are funds available; will get with property and discuss;

Bea Real Rider: consider building a small building behind the Roam Chief for beds and amenities during funerals;

M. Angela Thompson: addressed the concern about Council working together; would like to make some date to have meetings within the next few weeks; Council has the same goal to work for the people;

Carol Rouwalk: will the people be able to be informed or attend a meeting on the decision

Lillie Cumming Brant: mentioned that everyone in this room knows who Jesus is; the Bible says for us to pray; let Angela know she is praying for her and support her; thanked the young people for being here and the ideas they have;
