Dawna Hare: asked is any of the Council is available for the Presentation at OSU of the PN Penalty to Tribal member;

Charles Lone Chief: concerns about absolute relinquishment that was approved;

Pamela Cook: spoke on the relinquishment of her son and concerns with Indian preference at our own casinos; he was looked over on a position that was given to a non-Pawnee and non-Native person; her suggestion to her son was to sue the Tribe; and she urges the Tribe to uphold their Indian preference laws

Ann Collins: will have a silent auction and asked to end the auction at the Elders Luncheon

Ms. Collins was given permission to do so.

Sammye Adson: expressed she was sorry the person felt they had to relinquish; suggested shadowing and mentoring programs for tribal members who want to reform and work;

The PBC has set the next Council date for December 18th.

M. Angela Thompson: asked Ms. Cook if her son would come and talk to the Council about the situation:

Pamela Cook: she will talk with her son and he would probably come and talk with the Council

Motion made by Charles Lone Chief to reconsider Resolution #18-69 for absolute relinquishment, seconded by M. Angela Thompson.
