Call to Order & Invocation I.

Interim President Charles Lone Chief called the meeting to order at 3:10 pm and gave the invocation.

Roll Call - Declaration of Quorum II.

VII. Open Forum

Karen Haymond: why not pay out all the money all enrolled members regardless of age?

Dawna Hare: looking at the guidelines, it's really hard to justify paying out that full amount to our tribal membership without having to pay the funds back.

Bobby Robedeaux: Why are we doing mandatory COVID testing?

Charles Knife Chief: That was a decision by TERC, there are places that are requiring testing and some that are not. A lot of places are encouraging the testing. There are concerns but it is important to have the screening processes in place in all of our facilities.

Tonette Ponkilla: Has three statements, not questions. 1. How is this a Constitutional meeting happening today. 2. According to the Constitution, the current meeting should have had one-member call point of order, and 3. When we have one official officer, the Secretary on Council, why did she not cover the Presidency.

Charles Knife Chief: since those were just statements, there were not questions, please move on to the next.

Pam Cook: 1. What does the 4,743,400 entail? and 2. No cooking facilities for the election day would cause unsanitary conditions status.

Charles Knife Chief: We covered in detail the money, the total, and where it is going. Not sure about the second question.

Dawna Hare: the Pawnee Nation buildings are not going to be rented until August $1^{\rm st}$ and the Committee is following CDC recommendations. The Committee will be monitoring monthly. The building will be open for the election to continue.

More discussion on CARES Funding allocation.

Patricia McCray: Someone referred to the question on why the Secretary is not the acting President and I have asked Interim President Lone Chief to explain how that came down and why we are seated the way we are.

Charles Lone Chief: The Attorney General made an opinion and the way he interpreted the Constitution, said it was up to the remaining seated Council members to choose who wanted to be in that position. Further than that, he stated that when he [Mr. Lone Chief] was moved into the Acting Vice President position, he [Mr. Whiteshirt] had the opportunity to protest the appointment at that time and he did not. When [Mr. Whiteshirt] was recalled, automatically I [Mr. Lone Chief] was already there so I [Mr. Lone Chief] was moved into that position. That was the Attorney Generals opinion and it was up to the existing Council members.

Chad Smith: You can reference to the Constitution, Article 6, Section 1, it says: "In the event of Presidential vacancy, the Vice-President shall temporarily vacate their office and fulfill

the duties of the office of President until another president is elected by a majority of Pawnee tribal voters in a specially called election." In March, Mr. Lone Chief was selected by the Council to fill the vacancy left by the recall, he was serving as the Vice President when the April recall occurred. By operation of law, Mr. Whiteshirt was replaced by the acting Vice-President Lone Chief. So, he [Mr. Lone Chief] ascended to the office by the operation of law according to the Pawnee Nation Constitution.

The Council was asked if they would send a press release and post the Attorney General opinion. The consensus was yes to both.
