RESOLUTION # 15-15 January 28, 2015

RESOLUTION

Whereas, The Pawnee Nation of Oklahoma is a Federally Recognized Tribe, and

Whereas, The Pawnee Business Council is the supreme governing body of the Pawnee Nation and is authorized to conduct business on behalf of the Pawnee Nation in accordance with Articles IV, Sections 1 and 2 of the

Pawnee Nation Constitution and By-Laws; and

Whereas, The Pawnee Business Council met in special session on January 28, 2015, at the Pawnee Nation Tribal Roam Chief Center, duly authorized, with a

quorum present; and

Whereas, By Resolution 12-19, dated May 9, 2012, the Pawnee Business Council authorized the submission by the Nation to the Federal Transit Administration, Department of Transportation ("FTA"), of an application

for funds to perform a Planning Study; and

Whereas, By letter dated January 14, 2013, the FTA notified the Nation that the Nation's application for funds had been accepted and that it had been

granted the amount of \$25,000 to conduct a planning study; and

Whereas, Through the use of the grant funds, the Nation has completed a draft

Transit Plan; and

Whereas, The Nation wishes to apply for additional discretionary FTA funds to start

a Transit Program at the Pawnee Nation consistent with the Transit Plan;

and

Whereas, In order to apply for and obtain the additional discretionary funds, an

Authorized Representative of the Nation must provide certain

Certifications and Assurances to the FTA; and

Whereas, The Authorized Representative must be duly authorized by the Nation to

sign the Certifications and Assurances and to bind the Nation's

compliance; and

Whereas, FTA requires that the Nation's legal counsel affirm the Nation's authority

to make the Certifications and Assurances.

NOW, THEREFORE BE IT RESOLVED, that the Pawnee Business Council does hereby:

- 1. Authorize the President or Vice President of the Nation to sign the Certifications and Assurances for FYI 2015 and to thereby bind the nation's compliance with the Certifications and Assurances and all applicable federal statutes and regulations.
- 2. Authorize Janov Law Offices, P.C., to review the relevant documentation and provide the necessary affirmations.
- 3. Authorize the Nation's Transportation & Safety Department to take all steps necessary and proper to submit the necessary paperwork to FTA and take such other acts as are necessary to obtain funding for FY 2015.
