**RESOLUTION #15-80 OCTOBER 7, 2015** 

## RESOLUTION

Whereas, The Pawnee Business Council is the supreme governing body of the Pawnee Nation and is authorized to conduct business on behalf of the

Pawnee Nation and is authorized to conduct business on behalf of the Pawnee Nation in accordance with Article IV, Sections 1 and 2 of the

Pawnee Nation Constitution and By-Laws; and

Whereas, The Pawnee Business Council met in special session on October 7, 2015,

at the Pawnee Nation Multi-Purpose Building, duly authorized, with a

quorum present; and

Whereas, that amendments to Resolutions #13-30, 13-36, 13-86, 14-04, 14-27, 14-

28 and 14-61 be rescinded; and

Whereas, the drawdown amounts for the following original Resolutions, be recorded

at actual cost; and

Whereas, Resolution #13-86 for \$3,472.84 (Turkeys/Hams) and \$7,770.56 (Code

Talker Ceremony); #14-04 for \$19,006.72 (PN Museum); #14-27 for \$15,000 (Pawnee Indian Veterans Homecoming) and \$3,223.90 (Warrior Exhibit); #14-28 for \$2,000 (Code Talker Honor Day); and #14-61 for

\$8,140.39 (CHR Elder Assistance); and

Whereas, after further financial status review, it is not necessary to complete the

drawdowns as previously stated and the Pawnee Business Council now authorizes these funds be paid at actual cost from the Bank of America, Pawnee Nation of Oklahoma, Program Funds account for the funding

year.

NOW, THEREFORE BE IT RESOLVED the Pawnee Business Council does hereby rescind the amendments to Resolutions #13-30, 13-36, 13-86, 14-04, 14-27, 14-28, and 14-61 designated for Proceeds of Labor Drawdown funds and authorizes expenditures to be paid out of the Bank of America, Pawnee Nation of Oklahoma, Program Funds for funding years 2013 and 2014 at actual cost in the amount of \$58,614.41.
