Resolution # 15-83 October 22, 2015

RESOLUTION

Whereas, the Pawnee Business Council is the supreme governing body of the

Pawnee Nation and is authorized to conduct business on behalf of the Pawnee Nation in accordance with Articles IV, Sections 1 and 2 of the

Pawnee Nation Constitution and By-Laws; and

Whereas, the Pawnee Business Council met in special session on October 22, 2015,

at the Pawnee Nation Multi-Purpose Building, duly authorized, with a

quorum present; and

Whereas, the Pawnee Nation Business Council is donating \$50,000.00 in kind-man

power and equipment; and

Whereas, the Pawnee Business Council approved \$216,667.00 from Tribal Funds to

be used as a leveraging resource for the "Pawnee Nation Aquatic Health

Center"; and

Whereas, the Pawnee Business Council is leveraging a total amount of \$266,667.00

for the "Pawnee Nation Aquatic Health Center"; and

Whereas, the Pawnee Nation Business Council hereby readopts its Fiscal "Financial

Management" Policies and Procedures; and

Whereas, the Pawnee Nation Business Council readopts it Procurement/Contract

Management Policies, all in accordance with 2 CFR 200 and 24 CFR 1003 Federal Requirements which includes the required "Code of Conduct" whose content has not been modified since its inclusion in 2005, but the Tribal Leadership changed since the last resolution submitted, on a funded

project, which was dated May 20, 2015, Resolution 15-44.

NOW THEREFORE BE IT RESOLVED, that the Pawnee Business Council does hereby approve and authorize the submission of the leveraged amounts stated above to be applied towards the "Pawnee Nation Aquatic Health Center" that is being submitted for the FY2015 Indian Community Development Block Grant-Funding Cycle application to the U.S. Department of Housing and Urban Development and further approves, adopts and readopts all items as set forth above.
