RESOLUTION #16-76 AUGUST 24, 2016

## RESOLUTION

Whereas, The Pawnee Business Council is the supreme governing body of the

Pawnee Nation and is authorized to conduct business on behalf of the Pawnee Nation in accordance with Article IV, Sections 1 and 2 of the

Pawnee Nation Constitution and By-Laws; and

Whereas, The Pawnee Business Council met in special session on August 24, 2016,

at the Pawnee Nation Multi-Purpose Building, duly authorized, with a

quorum present; and

Whereas, the Pawnee Business Council, as the supreme governing body of the

Pawnee Nation, approved, endorsed and ratified the Pawnee General

Revenue and Taxation Act, as amended on April 25, 2007; and

Whereas, the Pawnee Nation Tax Commission met in a regular scheduled session on

June 21, 2016 with a quorum present, and submits the recommendation to

expand the sale of tribal tags for Veterans; and

Whereas, the Pawnee Business Council recognizes the need to strengthen the

Pawnee tribal government by providing for current expenses of the tribal government and to provide financing for expansion of tribal governmental operations and services through tax revenues provided and generated by

the General Revenue Taxation Ordinances; and

Whereas, the Pawnee Business Council finds it necessary to amend Chapter Ten

(10), Section 1012, Veterans Tags of the General Revenue and Taxation

Act.

**NOW, THEREFORE BE IT RESOLVED** the Pawnee Business Council does hereby approve the amendment to Chapter Ten (10), Section 1012 of the General Revenue and Taxation Act, as amended April 25, 2007 by Resolution #07-20, to read as follows:

Section 1012. Veterans Tags – All Veterans, with the exception of dishonorable discharged Veterans, shall be entitled to annually register a limit of two (2) motor vehicles at the special rate. All other Veterans vehicles will be registered at the regular rate. Proper proof of military service will be required.
