RESOLUTION #17-04 **JANUARY 11, 2017** 

## RESOLUTION

The Pawnee Business Council is the supreme governing body of the Whereas, Pawnee Nation and is authorized to conduct business on behalf of the Pawnee Nation in accordance with Article IV, Sections 1 and 2 of the

Pawnee Nation Constitution and By-Laws; and

The Pawnee Business Council met in special session on January 11, 2017, Whereas, at the Pawnee Nation Multi-Purpose Building, duly authorized, with a

quorum present; and

the Pawnee Nation of Oklahoma is a federally recognized Indian Tribe and Whereas,

legally authorized as a contracting entity; and

the Pawnee Nation of Oklahoma is organized in accordance with the Whereas,

provisions of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984),

as amended by The Act of June 15, 1935 (49 Stat. 378); and

the Pawnee Nation of Oklahoma requests to enter into an Indian Self-Whereas.

Determination and Education Assistance Act, Title 1, Section 102, Public Law 93-638 contract with the Secretary of the Department of Health and

Human Services, acting through the Indian Health Service (IHS); and

the Pawnee Nation of Oklahoma desires to plan, conduct, operate, and Whereas,

administer the programs, functions, services and activities (PFSAs) identified in the Health Education Model Contract and be responsible for the PFSAs

identified; and

authorities granted herein shall be continuing unless and until rescinded by Whereas,

separate action of this body.

NOW, THEREFORE BE IT RESOLVED the Pawnee Business Council does hereby approve the request to operate and administer the Health Education Model Contract with the Secretary of the Department of Health and Human Services, acting through the Indian Health Service (IHS).

BE IT FURTHER RESOLVED, that the Pawnee Business Council does hereby authorize the President, Executive Director, and the Grants and Contracts Office to review, negotiate, execute the contract and any modifications and sign required documents thereof throughout the existence of the Health Education program unless and until rescinded by separate action of this body.
