RESOLUTION #17-41 July 12, 2017

RESOLUTION

Whereas, The Pawnee Business Council is the supreme governing body of the Pawnee Nation and is authorized to conduct business on behalf of the

Pawnee Nation in accordance with Article IV, Sections 1 and 2 of the

Pawnee Nation Constitution and By-Laws; and

Whereas, The Pawnee Business Council met in special session on July 12, 2017, at

the Pawnee Nation Multi-Purpose Building, duly authorized, with a

quorum present; and

Whereas, the Pawnee Business Council, as the supreme governing body of the

Pawnee Nation, approved, endorsed and ratified the Pawnee General

Revenue and Taxation Act, as amended on April 25, 2007; and

Whereas, the Pawnee Business Council recognizes the need to strengthen the

Pawnee Tribal government by providing for current expenses of the tribal government and to provide financing for expansion of tribal governmental operations and services through tax revenue provided and generated by the

General Revenue Taxation Ordinances; and

Whereas, the Pawnee Nation Tax Commission met in a regular scheduled session on

June 20, 2017 with a quorum present, and submits the recommendation to

amend the Pawnee General Revenue and Taxation Act; and

Whereas, the Pawnee Business Council finds it necessary to make the addition of

Section 1013, Bill of Sale Only or Lost Title to Chapter Ten (10).

NOW, THEREFORE BE IT RESOLVED the Pawnee Business Council does hereby approve the addition of Section 1013 to Chapter Ten of the General Revenue and Taxation Act, as amended April 25, 2007 by Resolution #07-20, to read as follows:

Section 1013. BILL OF SALE ONLY OR LOST TITLE – Enrolled Pawnee Tribal Members shall be able to register a vehicle, boat, motorcycle, trailer or any other item ("item") that is subject to the Pawnee Nation Tax Commission General Revenue and Taxation Act with a bill of sale only or lost title. The Commission shall verify with the State of Oklahoma or state of origin item has no liens, holds or encumbrances against the title. Pawnee Nation Tax Commission shall also verify with Pawnee Nation Law Enforcement items is not lost nor stolen. An administrative fee in the amount of \$100 shall be assessed for completing the registration and title for item. The administrative fee shall be in addition to all other registration/penalty fees that may apply.
