RESOLUTION #17-49 AUGUST 9, 2017

RESOLUTION

Whereas, The Pawnee Business Council is the supreme governing body of the Pawnee Nation and is authorized to conduct business on behalf of the Pawnee Nation in accordance with Article IV, Sections 1 and 2 of the

Pawnee Nation Constitution and By-Laws; and

Whereas, The Pawnee Business Council met in special session on August 9, 2017, at the Pawnee Nation Building 64 Conference Room, duly authorized, with a

quorum present; and

Whereas, The Pawnee Nation supports and approves the proposed submittal to the Bureau of Indian Affairs (BIA) for the funding opportunity titled "Economic Development Feasibility Study Funding" under the category of

Native American Business Development Institute for the Fiscal Year

2017, in the amount of \$73,000; and

Whereas, The Pawnee Nation desires to exercise their sovereignty to utilize land and natural resources to develop a nutritious and sustainable food system

involving production systems that include traditional and commercial

foods for a commercial market; and

Whereas, The Pawnee Nation intends to pursue this economic opportunity, based upon the technical assistance and results provided, this will ensure a more

equitable distribution of nutritious foods that will benefit economic

growth; and

Whereas, the Pawnee Nation plans to use consulting services listed with in the

proposed submittal, the consultants will be responsible for aiding in the Comprehensive Business Plan and to further build relationships outside the study to continue pursuing a sustainable entity for the Pawnee Nation;

and

Whereas, The Pawnee Nation will publish results from the feasibility study on the Pawnee Nation website, social media sites, the newsletter Chaticks si

Pawnee Nation website, social media sites, the newsletter Chaticks si Chaticks and will have paper documentation for any member wishing to

view it at the Pawnee Nation offices.

NOW, THEREFORE BE IT RESOLVED the Pawnee Business Council does hereby approves and supports the proposed submittal for an "Economic Development Feasibility Study Funding" in the amount of \$73,000.00, an opportunity provided by the Bureau of Indian Affairs (BIA), Native American Business Development. This proposal will help develop a food system for a commercial market that will allow for economic opportunity and growth with the use of professional consultants. All information to be found with this feasibility study will be available to the public.
