RESOLUTION #17-62  
OCTOBER 10, 2017

## RESOLUTION

- Whereas,** The Pawnee Business Council is the supreme governing body of the Pawnee Nation and is authorized to conduct business on behalf of the Pawnee Nation in accordance with Article IV, Sections 1 and 2 of the Pawnee Nation Constitution and By-Laws; and
- Whereas,** The Pawnee Business Council met in special session on October 10, 2017, at the Pawnee Nation Building 64 Conference Room, duly authorized, with a quorum present; and
- Whereas,** the Pawnee Nation wishes to continue as a Native Government in Good standing with the National Congress of American Indians (NCAI); and
- Whereas,** the Pawnee Nation meets all requirements for Tribal Membership, pursuant to Article III – Members, Section B of the Constitution and By-Laws of the NCAI.

**NOW, THEREFORE BE IT RESOLVED** the Pawnee Business Council, which is the official governing body of the Pawnee Nation, hereby authorizes W. Bruce Pratt as the official principal tribal official, to take the necessary action to place the Pawnee Nation in membership in NCAI; and

**BE IT FURTHER RESOLVED** that, Tribal funds in the amount of \$6,500, based on the Tribal Membership dues schedule in the NCAI By-Laws, Article III, Section C2, are Authorized to be paid for NCAI membership;

**BE IT FURTHER RESOLVED** that, based on the tribal enrollment of 3,488 persons, the Pawnee Nation shall have 130 votes, in accordance with Article III – Members, Section B1(d);

**BE IT FINALLY RESOLVED** that pursuant to Article III, Section B 1(b) of the NCAI Constitution and By-Laws, the Pawnee Nation designate the following persons as Delegate and Alternate Delegate(s), and instructs them to become Individual Members in Good Standing with the NCAI in order to fulfill their responsibilities as Official Delegates to the National Congress of American Indians Annual Convention, Executive Council Winter Session and Mid-Year Conference.
