## RESOLUTION

- Whereas,** The Pawnee Business Council is the supreme governing body of the Pawnee Nation and is authorized to conduct business on behalf of the Pawnee Nation in accordance with Article IV, Sections 1 and 2 of the Pawnee Nation Constitution and By-Laws; and
- Whereas,** the Pawnee Business Council met in special session on October 26, 2017, at the Pawnee Nation Multi-Purpose Building, duly authorized, with a quorum present; and
- Whereas,** the Pawnee Tribal Development Corporation (PTDC) is chartered as a tribal corporation and governmental division of the Pawnee Nation of Oklahoma pursuant to Article IV, Sections 1 and 2 of the Constitution and By-Laws of the Pawnee Nation of Oklahoma and the Business Corporation Act of the Pawnee Nation; and
- Whereas,** the Tribal Constitution (By-Laws and Corporate Charter) are the "Supreme Law," and all persons subject to its jurisdiction therein; and the Business Council is the "supreme governing body" of the Pawnee Nation as a sovereign and federal recognized Indian government; furthermore, the Preamble of the Constitution states the authority to create sub-division entities, namely the PTDC; and
- Whereas,** may be recognized that the Business council has the authority to appoint The PTDC Board members; and
- Whereas,** the Pawnee Business Council met and elected to appoint **Kenneth Quigley** to serve as Pawnee Tribal Development Corporation Board member, Seat #6, whose inception begins on October 26, 2017, with ending term July 30, 2020.




## CERTIFICATION
