RESOLUTION

- Whereas,** The Pawnee Business Council is the supreme governing body of the Pawnee Nation and is authorized to conduct business on behalf of the Pawnee Nation in accordance with Article IV, Sections 1 and 2 of the Pawnee Nation Constitution and By-Laws; and
- Whereas,** The Pawnee Business Council met in special session on March 28, 2019 at the Pawnee Nation Resource Center, duly authorized, with a quorum present; and
- Whereas,** the Pawnee Nation Enrollment Committee met on January 15, 2019 to review all documentation submitted for eight (8) deceased tribal members and that the same was submitted to the Nasharo Council at a regular meeting held on March 16, 2019 for further review, seven (7) tribal members had passed since the Enrollment Committee meeting therefore fifteen (15) deceased tribal members were documented by the Nasharo Council by Resolution #19-01 for submission to the Pawnee Business Council for final approval by Pawnee Business Council Resolution; and
- Whereas,** fifteen (15) enrolled Pawnee Members have passed away; Aline Germaine Walker, 11-21-2018; Lance Vernet McLendon, 11-28-2018; Adeline Emerald Tonemah, 12-01-2018; Owen Echo Hawk Jr., 12-30-2018; George Dean Butler, 01-03-2019; Gina Marie Barker, 01-07-2019; Donald Jack Hedrick, 01-10-2019; Tommie Cherb, 01-11-2019; Rickey Felicano Moore, 01-20-2019; Wilbur M. Johnson Jr., 01-31-2019; Addie Latimer, 02-07-2019; Aline Ann Hyatt, 02-10-2019; Glen McGuire, 03-02-2019; Phyllis Loraine Burris, 03-11-2019; Darnell R. Carson, 03-12-2019.




CERTIFICATION
