RESOLUTION

Whereas, the Pawnee Business Council is the supreme governing body of the

Pawnee Nation and is authorized to conduct business on behalf of the Pawnee Nation in accordance with Article IV, Sections 1 and 2 of the

Pawnee Nation Constitution and By-Laws; and

Whereas, the Pawnee Business Council met in special session on May 1, 2019 at the

Pawnee Nation Resource Center, duly authorized, with a quorum present;

and

Whereas, the Pawnee Business Council has reviewed the applicants who filed for

tribal membership with the Pawnee Nation pursuant to the membership

provisions of the Pawnee Nation's Constitution; and

Whereas, the Pawnee Nation Enrollment Committee met on April 16, 2019 to

review all applications submitted for enrollment and submitted to the Nasharo Council twenty-five (25) approved eligible applications for enrollment.
