RESOLUTION #19-39 May 1, 2019

## RESOLUTION

Whereas, The Pawnee Business Council is the supreme governing body of the Pawnee Nation and is authorized to conduct business on behalf of the Pawnee Nation in

accordance with Article IV, Sections 1 and 2 of the Pawnee Nation Constitution

and By-Laws; and

Whereas, the Pawnee Business Council met in special session on May 1, 2019, at the

Pawnee Nation Resource Center, duly authorized, with a quorum present; and

Whereas, The Pawnee Nation wishes to conduct planning to determine the feasibility of

entering into a self-governance compact with the United States through the Secretary of the Department of Health and Human Services, Indian Health

Service (IHS); and

Whereas, the IHS offers funding for a Tribal Self-Governance Planning Cooperative

Agreement that will assist the Tribe to conduct legal and budgetary research and internal Tribal government planning and organization preparation relating to the

administration of health care programs; and

Whereas, if awarded, said cooperative agreement will provide resources to assist the Tribe

to make informed decisions about what programs, services, functions, and activities (PSFAs) or portions thereof, to assume should the Tribe decide to enter

into a self-governance compact; and

Whereas, Carol L. Nuttle, consultant, is a Pawnee Tribal Member who having retired from

the IHS Office of Tribal Self-Governance has the specialized knowledge, skills

and abilities to conduct planning on behalf of the Pawnee Tribe; and

Whereas, Carol L. Nuttle has offered to write the self-governance planning grant for the

Pawnee Nation at no cost to the Nation with the stipulation that should the grant be funded Ms. Nuttle will use the full funding received under this grant, less administrative costs, to conduct self-governance planning and present the results

to the Pawnee Business Council.

**NOW, THEREFORE BE IT RESOLVED** the Pawnee Business Council does hereby approve a sole source contract between Carol L. Nuttle, Consultant, and the Pawnee Nation to write a proposal to the IHS for a Tribal Self-Governance Planning Grant and the cost associated with writing and submitting this grant shall be at no cost to the Pawnee Nation.

**NOW, BE IT FURTHER RESOLVED** that should the IHS Planning grant be funded, a sole source contract shall be awarded to Carol L Nuttle, Consultant to conduct Self-Governance Planning for Tribal Self-Governance and submit a final report to the Pawnee Business Council.
