Whereas,
The Pawnee Business Council is the supreme governing body of the Pawnee Nation and is authorized to conduct business on behalf of the Pawnee Nation in accordance with Article IV, Sections 1 and 2 of the Pawnee Nation Constitution and By-Laws; and

Whereas, The Pawnee Business Council met in special session on August 14, 2019, at the Pawnee Nation Resource Complex, duly authorized, with a quorum present; and

Call process should be completed, submitted and approved by the Pawnee
Business Council by October 1, 2019; and

Whereas, The Budget Committee has reviewed all budgets and recommends approval to the Pawnee Business Council the 2020 Comprehensive Budget with an identified Budget Shortfall in the amount of \$ 129,280; and

Whereas, The Budget Committee and the Treasurer of the Pawnee Business Council will monitor and manage the shortfall accordingly; and
