RESOLUTION #19-84 NOVEMBER 13, 2019

## RESOLUTION

Whereas, The Pawnee Business Council is the supreme governing body of the

Pawnee Nation and is authorized to conduct business on behalf of the Pawnee Nation in accordance with Article IV, Sections 1 and 2 of the

Pawnee Nation Constitution and By-Laws; and

Whereas, The Pawnee Business Council met in special session on November 13,

2019, at the Pawnee Nation Roam Chief Event Center, duly authorized,

with a quorum present; and

Whereas, the Pawnee Tribal Development Corporation (TDC) is chartered as a tribal

corporation and governmental division of the Pawnee Nation of Oklahoma pursuant to Article IV, Sections 1 and 2 of the Constitution and By-Laws of the Pawnee Nation of Oklahoma and the Business Corporation Act of

the Pawnee Nation; and

Whereas, the Tribal Constitution (By-Laws and Corporate Charter) are the

"Supreme Law,: and all persons subject to its jurisdiction therein; and the Business Council is the "supreme governing body" of the Pawnee Nation as a sovereign and federal recognized Indian government; furthermore, the Preamble of the Constitution stated the authority to create sub-division

entities, namely the TDC; and

Whereas, the Pawnee Business Council retains the authority to appoint TDC Board

members and may appoint Business Council Members to the Board; and

Whereas, the Pawnee Business Council met and has appointed Reva Howell to

serve as Tribal Development Corporation Board member, Seat #5, whose inception begins on November 13, 2019 to fulfill a remainder term ending

on July 30, 2020.

**NOW, THEREFORE BE IT RESOLVED** the Pawnee Business Council does hereby appoint **Reva Howell** to serve as Tribal Development Corporation Board member, **Seat** #5, whose inception begins on November 13, 2019 to fulfill a remainder term ending on July 30, 2020.
