RESOLUTION

Whereas, The Pawnee Business Council is the supreme governing body of the Pawnee Nation and is authorized to conduct business on behalf of the

Pawnee Nation and is authorized to conduct business on benaif of the Pawnee Nation in accordance with Article IV, Sections 1 and 2 of the

Pawnee Nation Constitution and By-Laws; and

Whereas, the Pawnee Business Council met in special session on March 24, 2020, at

the Pawnee Nation Roam Chief Event Center, duly authorized, with a

quorum present; and

Whereas, in accordance with the Pawnee Nation Constitution on Recall of a Pawnee

Business Council Member, Article VII – Forfeiture, Recall, Removal, Section 2, Recall: "Upon receipt of a petition signed by twenty five per cent (25%) of the number of voters who voted in the last regular election call for a recall of any member of the Pawnee Business Council, it shall be the duty of the election commission to call and conduct within thirty (30) days an election on such recall. Recall shall be effective only if a majority of those voting shall vote in favor of such recall and that at least 50 per cent (50%) + one (1) of the number voting in the previous election vote in

recall election..."; and

Whereas, the Pawnee Nation Election Commission received and accepted the

petition to recall six (6) Pawnee Business Council members and conducted

a Recall Election on March 14, 2020; and

Whereas, the results of the recall election by a vote of the Pawnee membership was

to recall two (2) of the Pawnee Business Council members, Darrell

Wildcat, Vice-President and M. Angela Thompson, Treasurer; and

Whereas, the PN Election Commission has certified the recall election results on

March 19, 2020 for the two (2) members to be recalled.

NOW, THEREFORE BE IT RESOLVED the Pawnee Business Council does hereby accept the recall election results held on March 14, 2020 for the recall of Darrell Wildcat, Vice-President and M. Angela Thompson, Treasurer.
