My name is Jordan Kanuho, and I am running for reelection for Vice-President of the Pawnee Nation Business Council. I am the son of David and Suzanne Jim Kanuho and the grandson of James and Wanda Goodfox Kanuho, and the late Jennie Jim. I am also the greatgrandson of the late Lawrence Sr. and

Flora Lewis Goodfox and Phillip and Ella Pratt Jim. I am a member of the Kitkehahki, Pitahawirata, and Chaui bands. I am also of Navajo descent. I come from the Big Water and Many Goats clans of the Dine' people.

I was born and raised in Pawnee and graduated from Pawnee High School as a member of the class of 2004. Upon graduating high school, I attended OSU-IT in Okmulgee, OK, where I was honored to become a member of the Phi Theta Kappa Honor Society and was on the Registrar's Honor Roll. Since graduating from college, I have worked at four different engineering firms in Tulsa, including my current employment place.

I am also an ordained minister of the gospel of our Lord Jesus, and during my time in ministry, I have pastored Pawnee Indian Baptist Church for five years. I currently pastor at Belvin Baptist Church in Okmulgee, OK, where I have served diligently for four years now. My wife, Amanda, and I have lived in the Tulsa area for nine years.

Amanda and I have been happily married for 15 years. Amanda is employed by the Pawnee Nation College (PNC) as the Director of Student Affairs. She has held this position with PNC for four years.

Going into this election, those close to me knew that I needed to spend some time praying and considering running for reelection. I understand the commitment this position will require and the amount of attention and effort it takes to serve as your Vice-President. With that in mind, I did not want to enter this lightly, but with a sense of respect and regard for what the position of Vice President entails.

After much prayer and consideration, it is my privilege to serve you once again as your Vice President. I am thankful for the ones that God has placed in my life who have helped me work so hard and achieve so much in the short time I have served. It is this help that will allow me to continue to serve you to the best of my ability as Vice President of the Pawnee Nation Business Council.

As I ran last year for the office of Vice President, I stated that "I will do everything that I can possibly do to lay the groundwork that will start to get our Nation heading in the right direction for the betterment of our people." I believe that I have begun to do that in the efforts made within our tribal government and working diligently with that in mind.

I have had the opportunity to meet with several of our division directors and our employees at the Pawnee Nation. I have not been able to meet every one of our employees, and I still plan to do so in my time in office because I still believe that the better our programs operate, the better we can offer services to our Pawnee people. I have also had a chance to visit with some of our elders as I have been in office. I know more about particular areas to help them as a Nation. I continue to believe that we would not be where we are today if it were not for the road they helped pave to get us where we are, and we owe them a huge debt of gratitude for the work they have done. I have also worked diligently to be a voice to preserve and maintain our language and culture for the Pawnee Nation. We, as the Pawnee Business Council, have passed a resolution to standardize the Pawnee alphabet. We are also working to secure grants to fund our language program and hire our instructors as full-time employees at the Pawnee Nation. This will ensure the lasting impact of our Pawnee language. I continue to be a voice for our culture and work with our Cultural Resource Division to ensure that we maintain and secure a future for our Pawnee people for generations to come. Lastly, I continue to keep

in mind the generational aspect of my service as your Vice-President. I will continue to vote on items that I believe will help not only our members who are around today but will also benefit our future tribal members for generations to come. My aim is to not have a shortsighted vision of what we can do right now to make sure things are good, but what we can do to secure a better future for our Pawnee people in years to come.

I will do my best to serve our Pawnee People, and though I may not please everybody at some point as I serve these next four years as your Vice-President, my hope will be the main comment from my time in office is that I did everything in my ability with the Pawnee people in mind. Pawnee, Okla. – March 16, 2021, The Secretary of the Interior, Bureau of Indian Affairs, at the request of the Pawnee Nation (Resolution #21-11), has called for a Secretarial Election to be conducted for the attached amendment to the Constitution of the Pawnee Nation of Oklahoma, Article VII, Section 2, Recall. The revisions were proposed by the Pawnee Nation Governing Documents Committee with input from the Pawnee Nation Community and approved for submission by the Pawnee Business Council on January 6, 2021. The proposal was in response to last year's two recall elections which resulted in the recall of four of the Pawnee Business Council members. These revisions come before the people for a vote on May 1, 2021. The question that will be asked on the ballot is a YES or NO question. Yes, you are in favor of the amendments, or No you are not in favor of the amendments.

PROPOSED REVISIONS (RED-LINED):

ARTICLE VII-FORFEITURE, RECALL, SUSPENSION, REMOVAL

Section 2. Recall -

- (i) A petition for recall of any member of the Pawnee Business Council shall be:
 - a) filed withby the Pawnee Nation Election Commission, and
 - b) verified by the Enrollment Department that signed by twentythirty five per-cent (235%) of the number of voters who voted in the last regular election signed the petition, and
 - c) pay a filing fee not to exceed of fifty percent (50%) of the total cost of the last regular election \$4,000 payable to the Election Commission.
- (ii) After receipt of the verified recall petition, the Election Commission shall call and hold a recall election-conduct within sixty (60) business days but not before thirty (30) business days an election on such recall.
- (iii) Recall shall be effective only if a majority of those voting shall vote in favor of such a recall and that at least 50 fifty per-cent (50%) + one (1) of the number voting in the previous election vote in the recall election.
- (iv) Once a member has faced a recall attempt, no further recall action shall be brought against that member until at least twelve (12) <u>consecutive</u> months have passed. No member of the Pawnee Business Council shall be subject to <u>a</u> recall action within the first <u>sixtwelve</u> (612) months of that member's term.

ARTICLE VII – FORFEITURE, RECALL, SUSPENSION, REMOVAL Section 2. Recall

- (i) A petition for recall of any member of the Pawnee Business Council shall be:
 - a) filed with the Pawnee Nation Election Commission,
 - b) verified by the Enrollment Department that <u>thirty five percent (35%)</u> of the number of voters who voted in the last regular election signed the petition, and
 - c) pay a filing fee not to exceed fifty percent (50%) of the total cost of the last regular election payable to the Election Commission.
- (ii) After receipt of the verified recall petition, the Election Commission shall call and hold a recall election within sixty (60) business days but not before thirty (30) business days.
- (iii) Recall shall be effective only if a majority of those voting shall vote in favor of such a recall and that at least fifty percent (50%) + one (1) of the number voting in the previous election vote in the recall election.
- (iv) Once a member has faced a recall attempt, no further recall action shall be brought against that member until at least twelve (12) consecutive months have passed. No member of the Pawnee Business Council shall be subject to a recall action within the first twelve (12) months of that member's term.

Nawa Pawnee Nation Tribal Members: I am Pam Cook, and I am announcing my candidacy for the position of Secretary of the Pawnee Nation Business Council. I am the granddaughter of the late Julius Caesar, Kitkahaki, South Band. My mother was "Teetles" Lolita Caesar (Pawnee), married to Virgil Cook. I am running for Secretary because I believe

that I can make a difference for the betterment of our Pawnee people. I feel I am the best-qualified candidate for Secretary because I can provide a true and accurate record-keeping of PNB Council Minutes due to my background as a Court Clerk and court transcriptionist.

I have much to offer the Nation, with my diverse background and work experience in Tribal Government allows me to bring my tribal expertise and knowledge to the table in tribal affairs. I am not running for the prestige, nor for the money, nor for personal gain or recognition; however, I am running as a concerned tribal citizen with valuable experience and knowledge, and I have a great passion for my Pawnee people, which is reflected in my past work ethic. Since I am now retired, and my nest is empty, I can devote all my time, and attention and efforts to fully commit myself to the Position of Secretary to Pawnee Nation Business Council.

I am a person who possesses strong integrity and ethics, being an Officer of the Court and upholding the laws of our Tribal Nation. I also have a strong traditional and religious background and will do the right thing for our Pawnee Tribal Members.

As your Council Member, I will wisely represent you as I have the education, knowledge, and extensive work experience to read and interpret tribal laws, federal legislation, and tribal regulations. I have the ability to think independently and make complex business decisions on my own initiative as an individual person, and I feel that is a quality of a true leader. I have faced many obstacles in life and possess interdisciplinary skills to overcome adversity both professionally and personally. I am ready and willing to help take on the challenge of helping our Pawnee Nation get back on

track to become financially stable, independent, sound, 1980. I also was elected to serve as PNB Council Member and solvent, which will take a lot of planning with like businesses-minded people.

I come to you as a highly qualified candidate with over 35 years of tribal government experience in Tribal Programs, Grants and Contracts, Social Services, and Court Administration with the Tribal Courts and Federal Court of Indian Offenses, Budget, and Credit and Finance. My first job after graduating from OSU college in 1974, Legal Secretarial Science Diploma, I served as a Secretary to the Bureau of Indian Affairs, Department of Interior in Washington, D.C.in the Office of Personnel Management. I later returned home to Pawnee and worked at the Pawnee Agency BIA for 21 years, raising my children in Pawnee. I also worked in Washington D.C. from 1991 to 1995 in the Tribal Government Office, BIA.

After I completed my Degree in Criminal Justice from the University of Oklahoma in 2016, I transferred from Indian Health Services to Wind River Agency, in Fort Washakie, Wyoming, BIA, and was employed as a Legal Assistant Supervisor for the Court of Indian Offenses for the Shoshone and Arapaho Tribe. I have also worked as the Social Service Representative for the Sac and Fox Nation of Oklahoma, where I was responsible for 13 tribal social services programs.

I also worked for the Pawnee Nation as the Court Clerk for eight (8) years as the Court Administrator and Drug Court Coordinator, which gave me a great deal of satisfaction and a sense of fulfillment of helping my Pawnee Tribal Members complete their legal petitions such as Guardianships, Custody petitions, Name Changes, Divorce Petitions and Divorce Degrees, Adoption Petitions. I have transcribed accurate Court Minutes verbatim and made written court transcripts for the official court record.

I served as Secretary for the Pawnee Nation Employees Club, raising funds in their Employee Loan Department. I served as the Chairman of the Pawnee Indian Housing Authority responsible for building 42 Mutual Help Indian Homes for Pawnee Nation in 1981, and also served as Commissioner of the Pawnee Indian Housing Authority

under Elizabeth Blackowl's Presidency.

My Goals for our tribe: I would like to see qualified Pawnee Tribal Members with business degrees who have the business experience and background appointed to our Pawnee Tribal Development Corporation (PTDC) so that we may have sound enterprise developments to establish new businesses and to establish plans and goals to dissolve our 8 million dollar debt. More Tribal economic business ventures need to extend beyond the tribal casino in order to increase our tribal revenues.

I support our youth and would like to see more programs for our youth in more activities, counseling, and services, more drug and alcohol services, and more job opportunities to include Pawnee Preference.

I support the Elders in areas of health, assisted living services for elderly assistance, and transportation services. The elders deserve our respect, and they cannot be overlooked.

I would like to establish a Social Service Program funded with Revenue Allocation Funds and contract funds from the Bureau of Indian Affairs Social Services Program, General Assistance Program to establish programs such as Emergency Funds to all tribal members, supplemental heating and cooling programs, ricks of fire wood, gravel and driveway road program, work programs and services, supplemental eyeglasses and dental services.

The Leaders of the Pawnee Nation must lead our Nation in unity and focus on solving our governmental issues at hand in efforts to sustain ourselves as an independent, proud sovereign nation. I am up for the challenge at this election, and I am committed to work for you and represent you until the job is completed. I am asking for your vote on May 1, 2021, and I appreciate each and every one of you. I will put my best foot forward toward this endeavor, and it would be an honor and privilege to serve you.

There is no more incredible feeling than leaving a completed project knowing that you turned something, well frankly- ugly and dated into a beautiful, modern home that a tribal member will enjoy for years to come. Throughout my employment with the Pawnee Nation Housing Authority, I have changed from starting as a contractor to being a

I desire to support and help our Pawnee Nation with my knowledge of Indian Country. During my time at the University of Oklahoma, I pursued Public Administration and studied our Indigenous history by very impressive professors such as the late William Rice. My studies lead me to eventually work for the Sac and Fox (SFN) and the Iowa Tribe (ITO) and Alabama Quassarte Tribe of Oklahoma(AQT). Working as Director of Realty/Realty Officer of the SFN, and Director of Realty at the Iowa Tribe of Oklahoma, along with my education, allowed me to oversee each Tribe's Trust/Fee and Tribal and individual allotments.

I gained what is not readily obtained through the college educational setting. The Federal training received in management of Federal lands were from the Department of Interior, Bureau of Indian Affairs, Office of Special Trustee, Bureau of Land Management, and at the time managed for Indian Individual Money accounts as necessary to procure the Oil and Gas proceeds for the Individual/Tribes. Other work I provided for the AQT

was during the management of the Indian Reservation Roads era establishing inventory of road improvements. Also, during my time with ITO, I administered the Indian Community Development Block Grants, and succeeded in the development of potable water for this tribe allowing the newer developments. Also, water infrastructure extended the area for the Pow-wow Grounds and a storm shelter/library facility.

As of today, the ITO is thriving, and continued developments continue for their tribe.

Just quickly, with the SFN I was part of the 2nd new office of Environmental Services within Indian Country. During the new years of the National Environmental Policy Act (NEPA) legislation for Tribes, we were provided initiatives to develop programs that would maintain, address, mitigate environmental hazards and develop a study and inventory tribal lands. At that time, tribal lands were affected by the Oil and Gas industry, mining, injection of contaminants to their lands, the initiatives were under the auspices of the Cherokee Environmental Resources that at that time took the lead of the initiative.

I have had experience in budgetary management, Federal Records Management, Grant administration, and familiar with many legal documents throughout my career. Being trained at that time under many of the BIA instructions, we at that time were also charged in Will writing (at SFN) and enrollment at the ITO.

Each tribe I have worked with allowed them to grow. My

work at these nations fulfilled economic development down various avenues. I confidently bring with me first-hand experience and knowledge of budgetary management, economic development, Tribal sovereignty, and many other practices mentioned above.

I am enrolled all my life as a citizen of the Pawnee Nation and also bloodlines of the Pawnee Nation and of the Otoe-Missouria and Ponca nations. EXPANDING COVID-19 VACCINE ACCESS AT PAWNEE INDIAN HEALTH CENTER

Over the past year, the COVID-19 pandemic has taught us many lessons about keeping our communities and tribal members safe. From social distancing and hand washing wearing masks, to we remained vigilant in these practices to

protect our people and stay healthy. This was especially important because our population has a higher risk of serious complications from diabetes, heart disease, and others.

Thankfully, within the last few months, the COVID-19 vaccine was authorized and released to healthcare facilities, including the Pawnee Indian Health Center. We have been vaccinating first responders, staff and patients since mid-December. Since this time, our vaccine workgroup has administered over 3,500 vaccine doses. This may seem like a significant number, but it is not the majority of our active patient population. There are have a chart with us, please complete the still many people in the community that are reluctant to get the vaccine or may not know that the vaccine is available to them at this time.

To ensure widespread protection against the COVID-19 virus, the Pawnee Indian Health Center is expanding vaccine access to all individuals age 16 and up. This includes tribal members and descendants of a federally recognized tribe, as well as non-tribal members and non-natives.

Realizing that our native communities are interwoven with rural areas, towns, and cities, we will have a greater impact on stopping the COVID-19 virus by immunizing as many people as possible, including natives and nonnatives.

If you are age 16 and above and would like to be scheduled for a vaccine appointment or know someone that needs the vaccine, please call us at 918-762-6724 or 918-762-6639. A chart at Pawnee Indian Health Center is required to start the process. If you do not

PAWNEE NATION DIABETES PROGRAM

Nawa Akitaru!

The Pawnee Nation Diabetes Program's overall purpose focuses on three primary areas:

- 1. Prevention: Best practice is Physical Activity programming for Diabetes Prevention and Care, including the DHCS Wellness Program.
- 2. Resources: Provide outside resources and supplemental support to meet the needs of Diabetic Clients.
- 3. Outreach: Provide nutrition and health education; collaboration with outside entities to raise awareness of diabetes.

Our current prevention and outreach activities include:

• Nine-week community transformation challenge called "Shapeshiftin' In A Good Way," led by a certified trainer, Marlin Miller, of Massters of Gravity. Thirty individuals signed up to participate in this challenge. Included were screenings of blood



sugar, blood pressure, weight, waist & hip measurements, before and after photos, goal setting, 30- minute strength & resistance • daily workouts, one-on-one training sessions, and gym membership fees paid.

• Tiwari Club, also known as the walking/running/moving club. Sign-ups are throughout the year and include pre, mid, and post screenings of blood pressure and blood sugar, quarterly 50k or



100k challenges to receive club gear, and the shoe assistance program. Each participant is responsible for tracking their own physical activity and turning it into the Diabetes Program staff.

• The Wellness Program hosts free weekly workout classes for the community. On Mondays, there is a cardio class called FIGHT or RIPPED, and occasionally we will have Zumba. On Tuesdays, there is a Yoga class. All classes are

held at the Pawnee Nation Wellness Center Gym (blue gym) from 6 pm -7 pm. More information can be found on our Facebook page.

Collaborations with Pawnee Public Schools classrooms to talk about Diabetes Prevention and help lead physical activities.

All prevention and outreach activities are open to the Pawnee Community, Indigenous & non-Indigenous individuals of all ages. It is our goal to help preserve our wellness through motivation, support, and encouragement of physical activity.



Our current supplemental resources for diabetic clients in our program include:

- Prescription eyewear assistance up to \$150/yearly.
- A shoe assistance program to encourage clients to complete yearly lab work, eye, dental & foot exams, a nutrition visit, and two glucometer downloads.
- A case of nutritional supplement shakes, per a doctor's order, monthly.
- Blood glucose testing supplies such as test strips, lancets, alcohol wipes, cotton balls, and band-aids issued once a month. A glucometer to test blood sugar is issued once a year.
- Diabetic socks, one pair, per month.

Eligibility requirements for supplemental support can be found on the Pawnee Nation website under the Diabetes Program.

Râhikûcu' Gym offers a variety of equipment such as free weights, weight machines, different cardio machines as well as male and female restrooms, which include large lockers for your personal use and showers anytime of the day, 24/7. We also have a water bottle refill fountain.

With Covid-19 still among us throughout the nation, we are using caution and only allowing ten people in at a time, as well as requiring masks while entering the facility. Masks must be worn while going from station to station but may be taken off once at the station. Disinfectant spray and towels are provided to wipe down after use of our equipment. Staff in the facility also clean and disinfects throughout the day, making it our priority everyone stays safe and healthy. Our goal at Râhikûcu Gym is to provide a place for the community to become the healthiest version of ourselves so we can live a long life and allow our bodies to have a better chance to fight off any illnesses our people have already suffered from.

OVERDOSE IN OUR COMMUNITY

It has been a year now since the Covid-19 Pandemic came into being. We have endured over 500,000 deaths nationally. There have been many lives lost to the Covid-19 virus in our community. Many more are suffering from grief due to this. Some are seeking help, while some are self-medicating to try and cope with this affliction. This article will place focus on self-medicating concern with emphasis on overdosing.

The numbers for this article come from our ambulance service and those who are first responders for these occurrences. During this time frame, there were reports of (15) overdose cases in Pawnee, (9) were female and (6) were male. It has been reported that (6) were treated with naloxone as a life-saving measure. This is becoming a major concern for our community. On a national level, according to the Center of Disease Control (CDC), there was a decrease in overdose deaths of 4.1% from 2017 to 2018. In the most recent provisional data available ending in May 2020, there has been an increase of documented since provisional 12-month numbers began to be calculated in 2015.

CDC reports that this increase has been primarily driven by synthetic opioids. Data indicates that overdose deaths due to synthetic opioids have increased by 38.4%. State and local health departments report that most of the increase in synthetic opioid overdoses is primarily linked to illicitly manufactured fentanyl. Historically fentanyl was contained in (28) states east of the Mississippi due to high concentrations of white powder heroin in the heroin market. Since the pandemic, fentanyl has become much more prevalent in (10) Western states.

This increase in detrimental occurrences is having a severe impact among our own around Pawnee. On a personal level, I have a drastic increase in people coming through that have had usage of fentanyl either knowingly or fentanyl being added to the drug being used. These individuals are reporting incidents of

18.2% nationally. The increase is the largest suicide attempts and the need for additional psychiatric care after the inclusion of fentanyl into other substances.

> Since the onset of the Covid-19 Pandemic, we have been surrounded by negativity. Yes, negativity exists, while we need to find any comfort and help we can, we also have signs that a great deal of good is coming out of all of this. We are finding new ways to develop coping mechanisms. This includes using various forms of media such as Zoom and FaceTime to seek and obtain needed positive contacts. Replacing the basic human urge to find a shortcut to deal with trauma and pain is essential for our ability to come out ahead of all of this in the future. We can make our future bright if we choose to do so. We need to make sure that each of us does the best we can to take care of ourselves first, and then we can focus on those around us. The Pawnee Nation Learning Center staff have been on our toes, making sure we are taking all necessary precautions to keep our children safe and healthy during this pandemic. Our COVID-19 procedures were placed last April 2020, and we continue to follow them. Our staff is required to wear their masks at all times while working with our children. Parents are not allowed into the buildings during this time to help

stop the spread of infectious diseases. Staff and children's temperatures are taken before they can enter the building. We have received several donations for staff and children's masks, and we are always grateful for those that think of us! Six out of eleven staff members received their COVID-19 vaccines in January 2021. This was voluntary, not mandatory. The Pawnee Nation Learning Center's last exposure was in November of 2020.

The Pawnee Nation Learning Center has some great news to share! In February of 2021, we received \$430,084.00 from the Corona Response and Relief Supplemental Appropriation Act (CRRSA). These funds will be used to renovate the old fitness center into our new afterschool classroom! We are excited to have all our classrooms in one building. The spirit of cooperation for the betterment of Unity has reserved dates at the Women's in Pawnee when the need arises. We want to the community was on display early in March as the City of Pawnee, Pawnee Nation and the United Community Action Program came together to provide the financial support necessary for the Unity Healthcare Association to operate an additional COVID vaccination site in Pawnee.

Unity has already secured approval from the Oklahoma State Department of Health (OSDH) to administer the vaccine and, according to Unity spokesperson Kelly Davis, could receive vaccine from OSDH in time to offer injections on March 27.

"We've chosen to do this on Saturdays to make getting the vaccination a little easier for working people" Davis added, "and we are hoping to provide this service twice a month." Building on the Pawnee County Fairgrounds as the vaccination site but also has access to Pawnee Nation's COVID center on Morris Road.

"The biggest hurdle for Unity was putting together the money needed to obtain the supplies and equipment required by the Health Department to approve our application, like a freezer and recording thermometer, PPE for providers, syringes, sharps containers, disinfectant, Band-Aids, alcohol wipes, and office supplies," stated Unity founding member Dr. Gene Evans. The staff from Dr. Evans' clinic will provide the vaccinations.

"The willingness of the City, the Nation, and UCAP to pitch in on this is evidence of their commitment to making things better thank Mayor Tom Briggs, President Walter Echo-Hawk, and Executive Director Johnny Bryant for their eagerness to help us solve this problem," Dr. Evans added.

Unity anticipates that the Moderna vaccine will be made available for its clinic, but OSDH will make the final decision on which vaccine is delivered closer to the proposed date. Individuals interested in receiving the vaccine must sign up on OSDH's vaccination portal.
