

PAWNEE NATION LIQUOR CONTROL COMMISSION
SCHOLARSHIP PROGRAM

The Pawnee Nation Liquor Control Commission will hold a semi-annual scholarship for enrolled Pawnee Tribal members or any employee that works for Pawnee Nation or a Pawnee Nation entity. Open to anyone that is employed or who is enrolled in high school, vocational, college, or university full-time and/or a member working on a particular certification. Each applicant will follow the application process and submit a written essay for consideration. The amount of the scholarship awarded will be at the discretion of the Commission based upon the availability of funds. This is a two-time award, made in the month of August and January. There will be no limit on how many times an applicant may apply.

Qualifications:

1. Must be an enrolled Pawnee Tribal member, Pawnee Nation Employee and/or Pawnee Nation entity;
2. Studying for a degree and/or certification, Vocational school in their field of study;
3. Enrolled full-time in a Junior College, Trade School or University and provide class schedule;

4. For Certification provide the following: Company or website who is providing the certification, Name of vocational school, cost amount, and who to make the payment out to;
5. Vocational/University provide an unofficial transcript, class schedule, letter of acceptance (need for certification only). ; and
6. Submit a 250 word essay on why you chose the field of study and how it would benefit your advancement in your field/industry. [can chose any subject for the essay]

Deadline for applications will be June 30th and September 15th of each year. Each awarded scholarship will be awarded in the month of August and January in the form of a check directly to the applicant or company offering the certification.
