## RESOLUTION

- Whereas,** the Pawnee Business Council is the supreme governing body of the Pawnee Nation and is authorized to conduct business on behalf of the Pawnee Nation in accordance with Article IV, Sections 1 and 2 of the Pawnee Nation Constitution and By-Laws; and
- Whereas,** the Pawnee Business Council met in a Regular Meeting on April 4, 2023, at the Pawnee Nation Roam Chief Event Center, duly authorized, with a quorum present; and
- Whereas,** the Pawnee Nation Enrollment Committee met on March 8, 2023 to review all documentation submitted for six (6) deceased tribal members and were submitted to the Nasharo Council for review; and
- Whereas,** the Nasharo Council met at a regular meeting on March 22, 2023 for further review of eight (8) deceased tribal members as documentation was received of two (2) tribal members passing since the Enrollment Committee meeting and were documented by Nasharo Council Resolution #23-03 for submission to the Pawnee Business Council; and
- Whereas,** one (1) tribal member has passed since the Nasharo Council meeting; and
- Whereas,** nine (9) enrolled Pawnee Members have passed away; Robertajean Salmon Ahdunko, 12-20-2022; Sidney Joseph Moore Jr., 01-08-2023; Donald Timothy Prigmore, 01-12-2023; Sandra Rowe Saulter, 12-31-2022; Ronald James Rice Sr., 02-01-2023; Lucy Delores No Ear, 02-02-2023; Evelyn Edgarrita Long, 03-08-2023; Joseph James Hawkins, Jr., 03-16-2023, Cecil Leon Sterne, 03-24-2023.

**NOW, THEREFORE BE IT RESOLVED,** the Pawnee Business Council does hereby approve to note the date of death of nine (9) deceased members on the Membership Roll and remove them from the Annuity Roll.


## CERTIFICATION
