RESOLUTION

- Whereas,** The Pawnee Business Council is the supreme governing body of the Pawnee Nation and is authorized to conduct business on behalf of the Pawnee Nation in accordance with Article IV, Sections 1 and 2 of the Pawnee Nation Constitution and By-Laws; and
- Whereas,** The Pawnee Business Council met in a quarterly meeting on June 3, 2023, at the Pawnee Nation Roam Chief Event Center, duly authorized, with a quorum present; and
- Whereas,** the Business Council recognizes that it is in the best interest of the Pawnee Nation to have an enrollment division to meet the needs of its Tribal members; and
- Whereas,** issuing Indian Preference Form (BIA-4432) allows applicants to apply for federal and Tribal employment under Indian Preference and will be an added service to the Pawnee people.

NOW, THEREFORE BE IT RESOLVED the Pawnee Business Council does hereby authorize the following, to certify and sign the Indian Preference Form (BIA-4432) namely Misty M. Nuttle, President of the Pawnee Business Council; George Gardipe, Secretary of the Pawnee Business Council; Jenifer Gover LittleSun, Pawnee Nation Executive Director; or Carrie Peters, Enrollment Director.


CERTIFICATION

On Saturday, May 6, 2023, the Pawnee Nation Election Commission carried out the Election of the Pawnee Business Council as set forth by the Constitution of the Pawnee Nation of Oklahoma. The election was carried out in accordance with the Election Act of the Pawnee Nation with 0 (zero) protests filed during the protest period. The PN Election Commission is hereby declaring the results of the votes submitted on Saturday May 6, 2023, as Official Results.
