RESOLUTION

Whereas, the Pawnee Business Council is the supreme governing body of the Pawnee Nation and is authorized to conduct business on behalf of the Pawnee Nation in accordance with Article IV, Sections 1 and 2 of the Pawnee Nation Constitution and By-Laws; and

Whereas, the Pawnee Business Council met in a Regular Meeting on July 18, 2023, at the Pawnee Nation Roam Chief Event Center, duly authorized, with a quorum present; and

Whereas, the Pawnee Business Council has reviewed the applicants who filed for tribal membership with the Pawnee Nation pursuant to the membership provisions of the Pawnee Nation's Constitution; and

Whereas, the Pawnee Nation Enrollment Committee met on July 11, 2023, to review applications and submitted nineteen (19) approved eligible applicants to the Nasharo Council for further review; and

Whereas, the Nasharo Council held a regular meeting on July 15, 2023 and twenty (20) applications for enrollment were reviewed including one (1) applicant previously tabled by the Nasharo Council and twenty (20) were approved by Nasharo Council Resolution #23-04 for submission to the Pawnee Business Council for final approval by Pawnee Business Council Resolution; and
