RESOLUTION

Whereas, The Pawnee Business Council is the supreme governing body of the Pawnee Nation and is authorized to conduct business on behalf of the Pawnee Nation in accordance with Article IV, Sections 1 and 2 of the Pawnee Nation Constitution and By-Laws; and

Whereas, the Pawnee Business Council met in special session on October 3, 2023, at the Pawnee Nation Resource Center, duly authorized, with a quorum present; and

Whereas, Pursuant to the Pawnee Nation's Fiscal Policies and Procedures the Budget Call process should be completed, submitted, and approved by the Pawnee Business Council by October 1, 2023; and

Whereas, the Budget Committee has reviewed all Federal budgets and recommends approval to the Pawnee Business Council the 2024 Federal budgets totaling \$6,052,844; and

Whereas, the Budget Committee and the Treasurer of the Pawnee Business Council will monitor the budgets; and

Whereas, The Pawnee Business Council wishes to approve the Pawnee Nation of Oklahoma 2024 Federal Budgets totaling \$6,052,844; and




CERTIFICATION
