## RESOLUTION

- Whereas,** the Pawnee Business Council is the supreme governing body of the Pawnee Nation and is authorized to conduct business on behalf of the Pawnee Nation in accordance with Article IV, Sections 1 and 2 of the Pawnee Nation Constitution and By-Laws; and
- Whereas,** the Pawnee Business Council met in special session on May 25, 2021 at the Pawnee Nation Building 64 Conference Room, duly authorized, with a quorum present; and
- Whereas,** the Pawnee Nation Enrollment Committee met on April 20, 2021 to review all documentation submitted for twenty-eight (28) deceased tribal members and that the same was submitted to the Nasharo Council at a quarterly meeting held on May 13, 2021 for further review, two (2) tribal members had passed since the Enrollment Committee meeting therefore thirty (30) deceased tribal members were documented by the Nasharo Council by Resolution #21-01 for submission to the Pawnee Business Council for final approval by Pawnee Business Council Resolution; and


## CERTIFICATION
