## RESOLUTION

**Whereas,** The Pawnee Business Council is the supreme governing body of the Pawnee Nation and is authorized to conduct business on behalf of the Pawnee Nation in accordance with Article IV, Sections 1 and 2 of the Pawnee Nation Constitution and By-Laws; and

**Whereas,** the Pawnee Business Council met in special session on September 21, 2021, at the Pawnee Nation Building 64, Conference Room, duly authorized, with a quorum present; and

**Whereas,** Pursuant to the Pawnee Nation's Fiscal Policies and Procedures the Budget Call process should be completed, submitted and approved by the Pawnee Business Council by October 1, 2021; and

**Whereas,** the Budget Committee has reviewed all Federal budgets and recommends approval to the Pawnee Business Council the 2022 Federal budgets totaling \$5,658,927.00; and

**Whereas,** the Budget Committee and the Treasurer of the Pawnee Business Council will monitor the budgets; and

**Whereas,** The Pawnee Business Council wishes to approve the Pawnee Nation of Oklahoma 2022 Federal Budgets totaling \$5,658,927.00; and




### CERTIFICATION
