RESOLUTION

- Whereas,** the Pawnee Business Council is the supreme governing body of the Pawnee Nation and is authorized to conduct business on behalf of the Pawnee Nation in accordance with Article IV, Sections 1 and 2 of the Pawnee Nation Constitution and By-Laws; and
- Whereas,** the Pawnee Business Council met in special session on September 21, 2021, on Pawnee Nation Microsoft TEAMS duly authorized, with a quorum present; and
- Whereas,** the Pawnee Business Council has reviewed the applicants who filed for tribal membership with the Pawnee Nation pursuant to the membership provisions of the Pawnee Nation's Constitution; and
- Whereas,** the Pawnee Nation Enrollment Committee met on September 8, 2021 to review applications submitted then submitted to the Nasharo Council seventy-eight (78) approved eligible applications. At a Nasharo Council special meeting held on September 16, 2021, seventy-eight (78) applications for enrollment were reviewed and approved by the Nasharo Council by Resolution #21-03 for submission to the Pawnee Business Council for final approval by Pawnee Business Council Resolution; and


CERTIFICATION
