RESOLUTION

- Whereas,** the Pawnee Business Council is the supreme governing body of the Pawnee Nation and is authorized to conduct business on behalf of the Pawnee Nation in accordance with Article IV, Sections 1 and 2 of the Pawnee Nation Constitution and By-Laws; and
- Whereas,** the Pawnee Business Council met in special session on September 21, 2021, on Pawnee Nation Microsoft TEAMS, duly authorized, with a quorum present; and
- Whereas,** the Pawnee Nation Enrollment Committee met on September 8, 2021 to review all documentation submitted for sixteen (16) deceased tribal members and that the same was submitted to the Nasharo Council at a special meeting held on September 16, 2021 for further review, one (1) tribal member had passed since the Enrollment Committee meeting therefore seventeen (17) deceased tribal members were documented by the Nasharo Council by Resolution #21-03 for submission to the Pawnee Business Council for final approval by Pawnee Business Council Resolution; and




CERTIFICATION
