RESOLUTION

Whereas, The Pawnee Business Council is the supreme governing body of the Pawnee Nation and is authorized to conduct business on behalf of the Pawnee Nation in accordance with Article IV, Sections 1 and 2 of the Pawnee Nation Constitution and By-Laws; and

Whereas, the Pawnee Business Council met in special session on October 18, 2021, on Pawnee Nation Microsoft TEAMS, duly authorized, with a quorum present; and

Whereas, the Pawnee Nation of Oklahoma is a federally recognized tribal entity as verified in the Federal Register/Vol. 77, No. 155/January 31, 2020/Notice and based upon this status is eligible to apply for funding, as required by 24 CFT 1003.5(b); and

Whereas, the Pawnee Nation desires to apply for funds available from the U.S. Department of Housing and Urban Development for assistance under the Indian Community Development Block Grant – American Rescue Plan Act (ICDBG – ARP) funding program for the “*Pawnee Nation ARP Project*” proposal in the amount of \$1,035,000.00 with no match requirement; and

Whereas, the Pawnee Nation hereby certifies that the citizen participation requirements identified in 24 CFR 1003.604(a) and Notice PIH-2021-22 have been met for ICDBG-ARP project, “*Pawnee Nation ARP Project*” being proposed; and

Whereas, the Pawnee Business Council on behalf of the Pawnee Nation of Oklahoma does hereby approve the submission of the ICDBG-ARP grant application for the “*Pawnee Nation ARP Project*”

NOW, THEREFORE BE IT RESOLVED the Pawnee Business Council does hereby approve the submission of the Indian Community Development Block Grant – American Rescue Plan Act, grant application for the “*Pawnee Nation ARP Project*” to the U.S. Department of Housing and Urban Development and further approves, adopts and readopts all items as set forth above, having met the Citizen Participation requirements in accordance with 24 CFR 1003.604(a).


BE IT FURTHER RESOLVED, the following designees, including the Pawnee Business Council President, Vice-President, and the Pawnee Nation Executive Director are hereby authorized to negotiate and execute the contract and any amendments thereof during the period of the grant.


CERTIFICATION
