RESOLUTION

- Whereas,** the Pawnee Business Council is the supreme governing body of the Pawnee Nation and is authorized to conduct business on behalf of the Pawnee Nation in accordance with Article IV, Sections 1 and 2 of the Pawnee Nation Constitution and By-Laws; and
- Whereas,** the Pawnee Business Council met in virtual special session on February 15, 2022, on Pawnee Nation Microsoft TEAMS, duly authorized, with a quorum present; and
- Whereas,** the Pawnee Nation Enrollment Committee met on February 9, 2022, to review all documentation submitted for twenty-one (21) deceased tribal members and that the same was submitted to the Nasharo Council at a regular meeting held on February 12, 2022 for further review and twenty-one (21) deceased tribal members were documented by the Nasharo Council by Resolution #22-02 for submission of final approval by Pawnee Business Council Resolution; and

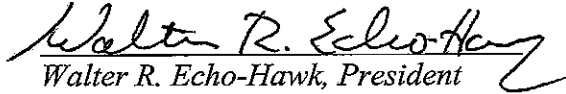
CERTIFICATION
